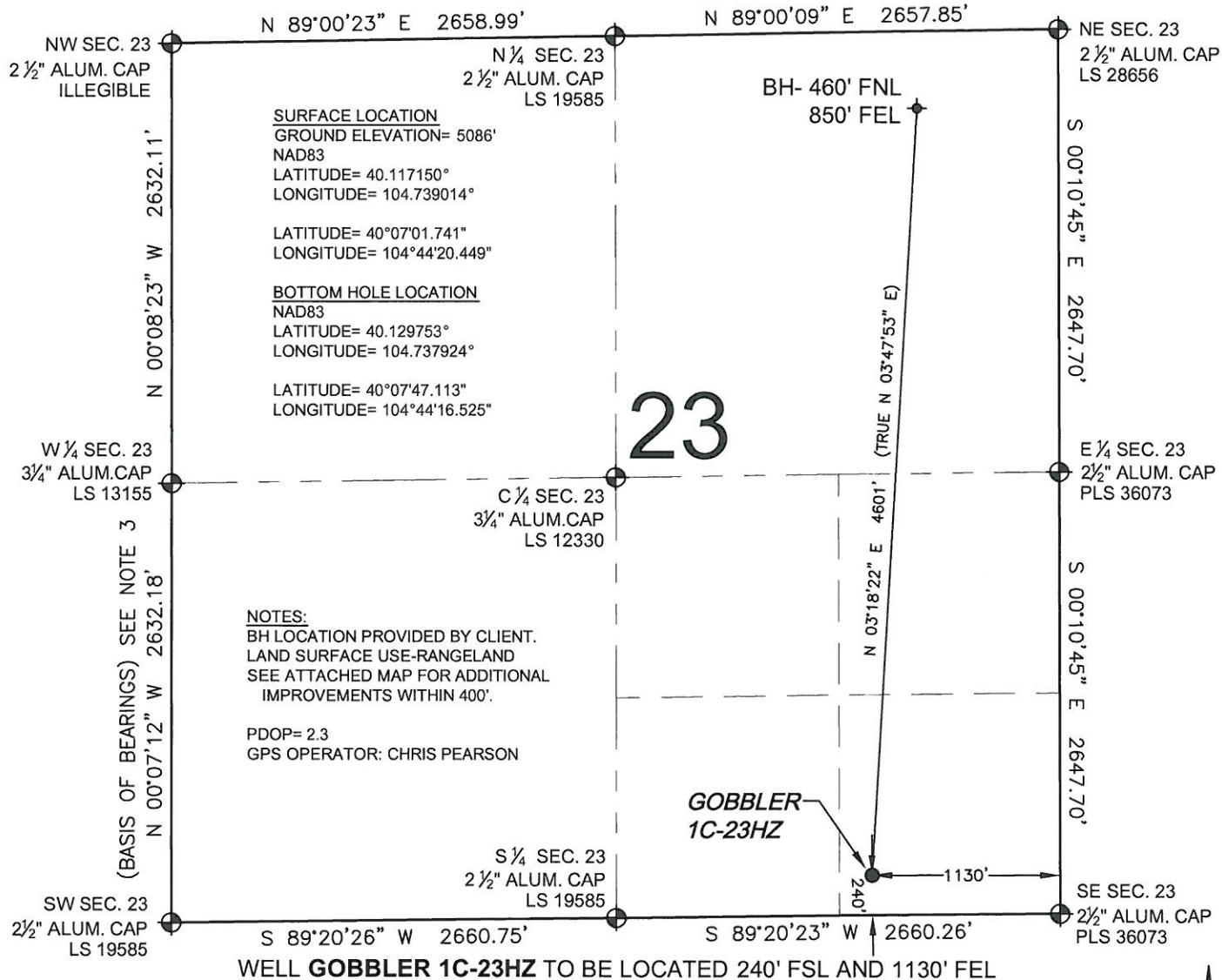


WELL LOCATION CERTIFICATE: GOBBLER 1C-23HZ

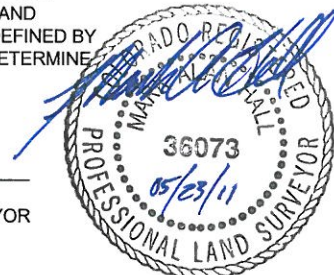
