Enclosed are copies of the following documents to assist you in your review and approval of NEI's proposed APD for the captioned well:

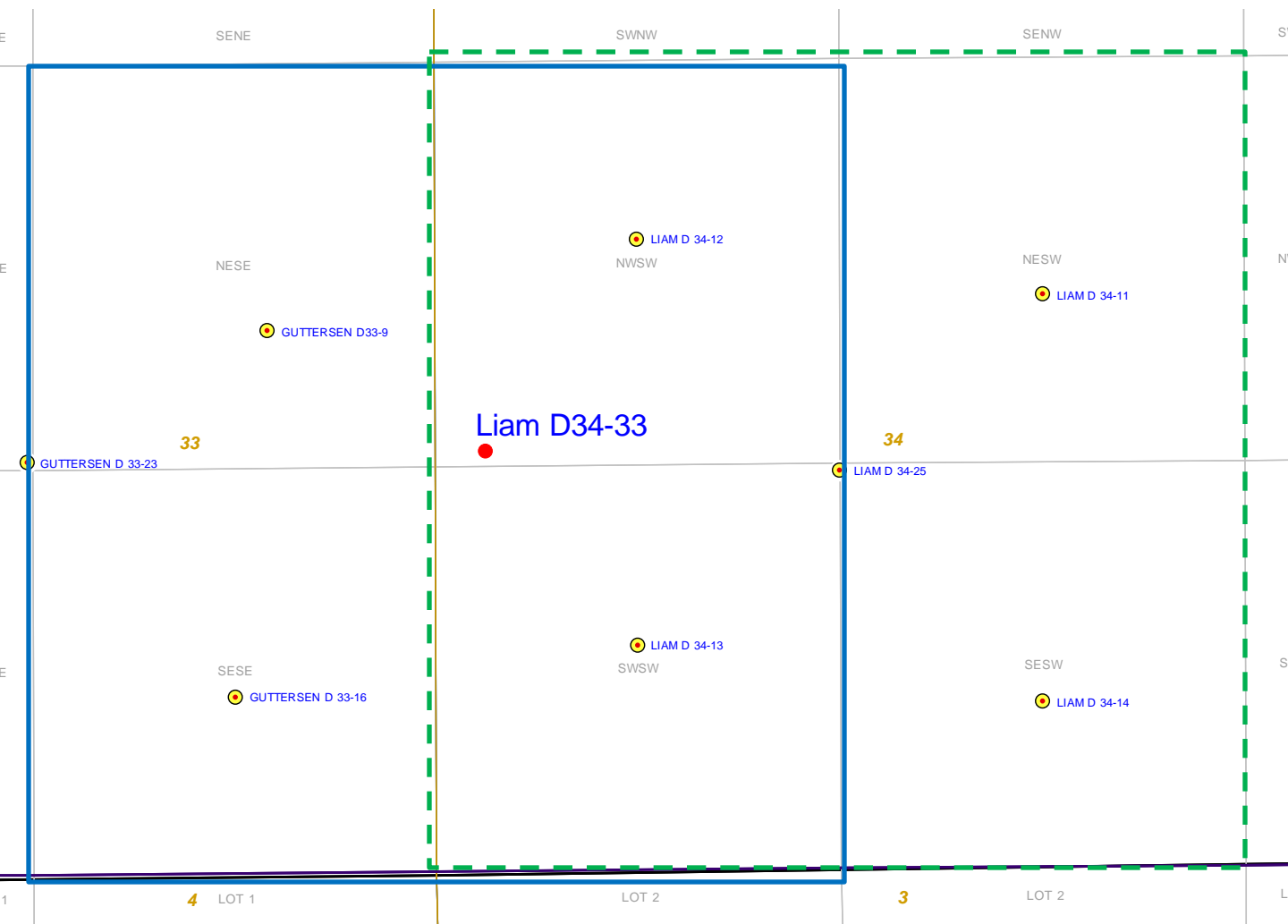

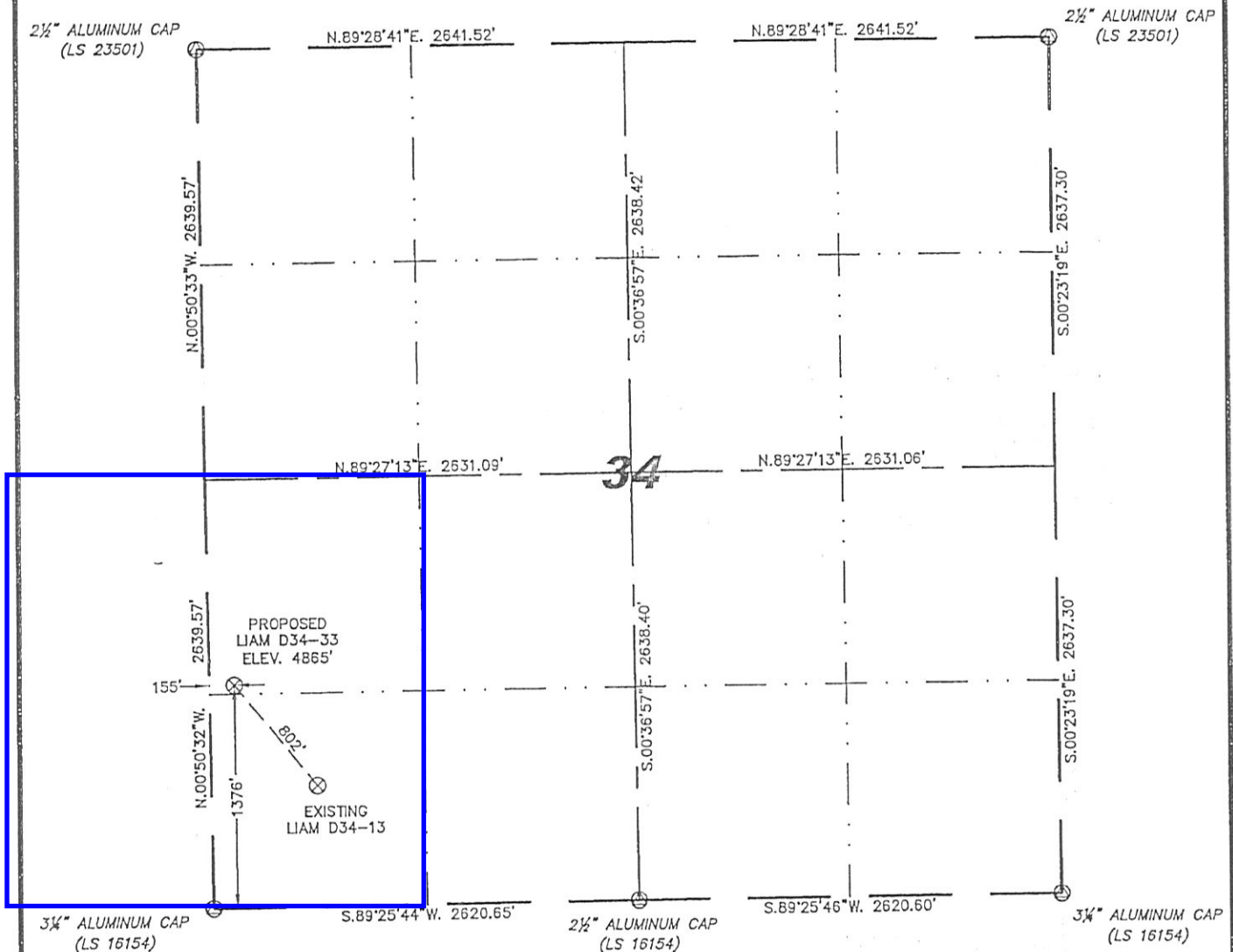
