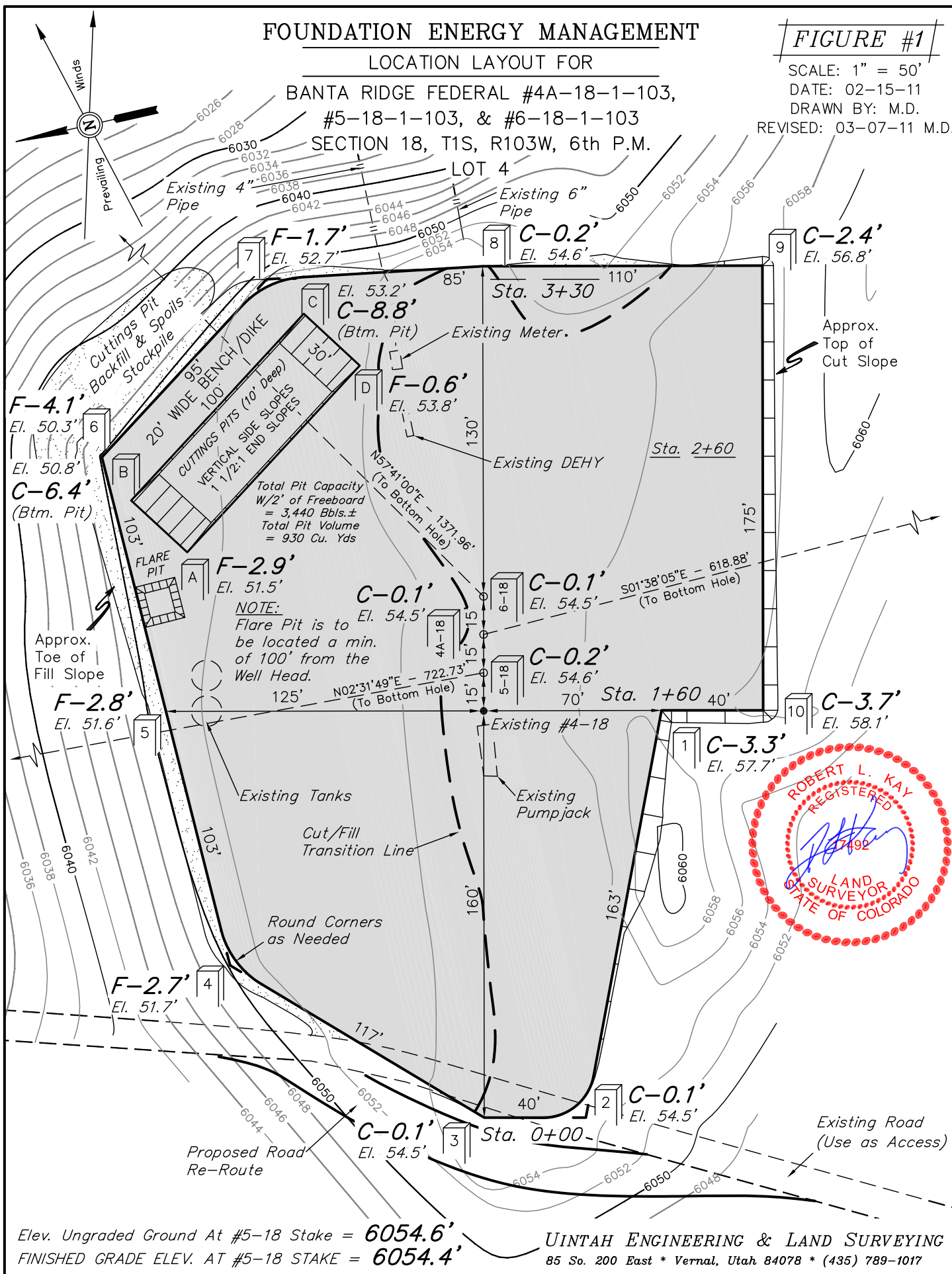

## TYPICAL CROSS SECTIONS FOR

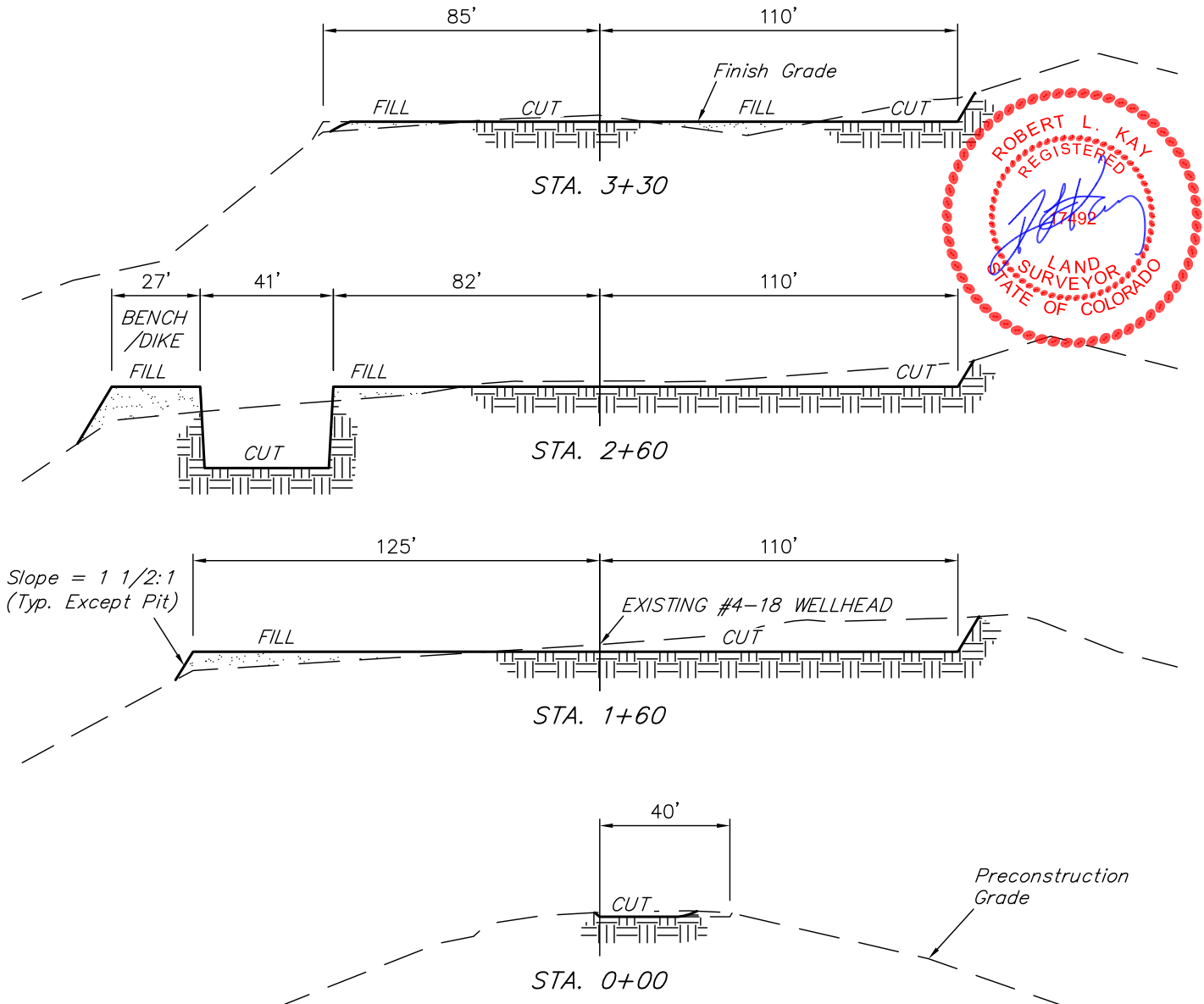

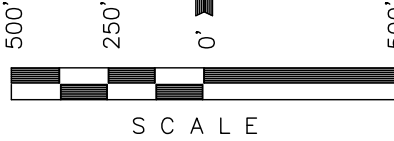
