Clayton,

The following conditions of approval will apply to the 392 Ventures Pad:

- Operator must implement site-specific best management practices in accordance with good engineering practices, including, but not limited to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to protect the irrigation ditches surrounding the oil and gas location from a release of drilling, completion, produced fluids, and chemical products.
- Location is in a sensitive area because of potential for adverse impacts to ground water; therefore all pits will be lined.
- Provide temporary engineering controls to prevent uncontrolled public access during drilling and completion activities.
