A STRIP OF LAND, 50.00 FEET IN WIDTH, FOR A PROPOSED ROAD RIGHT-OF-WAY, ALL SITUATED WITHIN THE WEST HALF OF THE WEST HALF OF SECTION 11, TOWNSHIP 6 SOUTH, RANGE 91 WEST, 6TH PRINCIPAL MERIDIAN, MOFFAT COUNTY, COLORADO, THE BOUNDARIES THEREOF BEING 25.00 FEET ON EITHER SIDE OF THE FOLLOWING DESCRIBED CENTERLINE:

COMMENCING AT THE SECTION CORNER COMMON TO SECTIONS 2, 3, 10 AND 11, TOWNSHIP 6 SOUTH, RANGE 91 WEST, 6TH PRINCIPAL MERIDIAN, MOFFAT COUNTY, COLORADO, BEING A BRASS CAP AND IRON PIPE MONUMENT, THENCE SOUTH 32°51'53" EAST, 2,415.60 FEET TO THE **TRUE POINT OF BEGINNING**, A POINT ON OR NEAR THE EASTERLY PROPERTY LINE OF CHARMAINE A. WEBER LANDS;

THENCE SOUTH 86°17'35" WEST, 13.62 FEET;

THE TOTAL LENGTH OF THE PROPOSED ROAD RIGHT-OF-WAY ACROSS CHARMAINE A. WEBER LANDS AS DESCRIBED ABOVE IS 2882.77 FEET, OR 174.71 RODS, CONTAINING 3.309 ACRES, MORE OR LESS.
