Based on review of information presented it appears that no further action is necessary at this time for the two referenced releases. However, should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or if ground water is found to be significantly impacted, then further investigation and/or remediation activities may be required at the site.
