


# WELL LOCATION CERTIFICATE: SWIFT 24-65

SECTION 24, TOWNSHIP 6 NORTH, RANGE 66 WEST, 6TH P.M.




WELL SWIFT 24-65 TO BE LOCATED 932' FNL AND 1715' FEL
