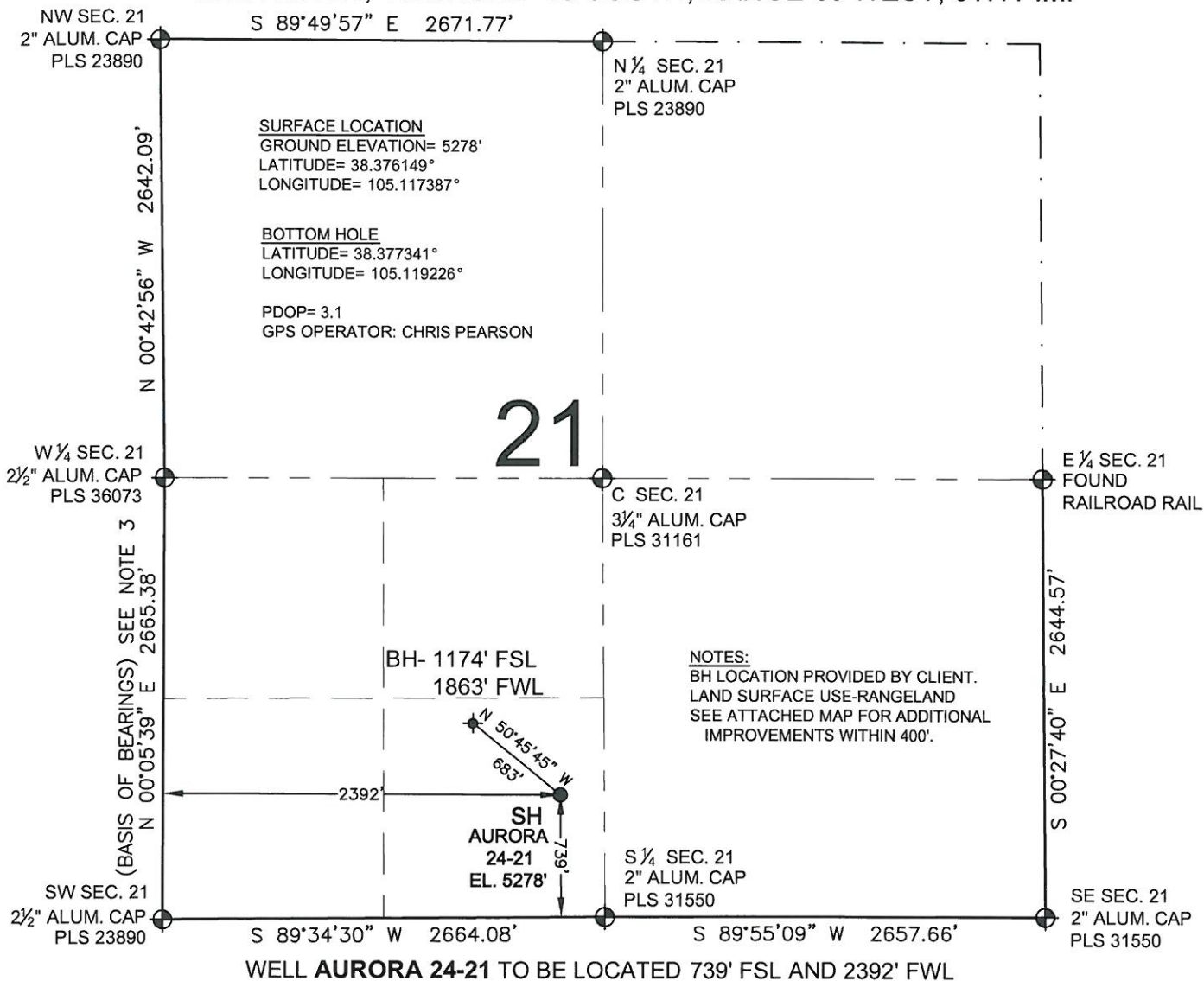


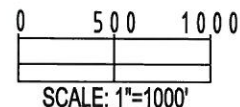
WELL LOCATION CERTIFICATE: AURORA 24-21
