Dear Mr. and Mrs. Jurajda:

Pioneer Natural Resources USA, Inc. notified you of our intentions to drill the Hunter 22-17 wells by letter dated November 12, 2010, after having sent numerous letters to your predecessors-in interest on March 29, 2010, June 3, 2010, July 9, 2010, July 14, 2010 and September 23, 2010. Note that under these letters, we proceeded with the surveying of the proposed wellsite and right-of-way, and it is my understanding that you have checked the proposed wellsite.

Since November 12, 2010, Chris Sanchez has attempted to set up a consultation with you by telephone calls dated February 4, 15, 23, 24, March 21, 31, May 11, and June 9, 2011, and the undersigned contacted you on May 19, 2011. It is now June 13, 2011, and we are no closer to a firm consultation date. As you are probably aware, Pioneer has leased the minerals under your surface estate in their entirety and has the rights to enter onto your land to explore its leasehold rights. We always prefer to consult with the surface owner in exercising these rights and feel we have acted in good faith in doing so on this well.

This letter shall serve as notice that Pioneer Natural Resources USA, Inc. intends to conduct drilling, road and/or pipeline operations on and near your property located in T33S-R67W Sec. 17: Rancho Escondido Unit 3, Lot 3C (SE/4NW/4) on or after 30 days from the date of this letter.

There may be large truck and construction traffic in the area at this time.

Relative to our drilling the subject well listed above, we are pleased to enclose two Surface Damage Releases and a Right-of-Way Agreement for your review and execution. Our standard policy is to pay \$3,500.00 per drillsite location, as compensation for surface damages associated with the drilling of the above referenced wells, and \$25.00 per rod for Right-of-Way Agreements, as compensation for the construction of roads and pipelines.

Should everything meet with your approval, please sign, date, and notarize one copy of each original document together with the enclosed W-9 form and return them to us in the envelope provided. The other set marked "Copy" is for your records. Upon our receipt of the signed documents and W-9 form, we will then issue you a check in the amount of \$8,127.50 which represents \$7,000.00 net payment for your 100% interest for the Surface Damage Releases and \$1,127.50 for your net footage of 744 feet, or 45.10 rods times \$25.00/rod in the included Right-of-Way Agreement.


