Moe,

The COGCC is reviewing the Form 2A (#400181837) for the Hunter Aurora/Coho location, located in the SESW Sec 21 T19S R69W Fremont County, Colorado. The COGCC requests the following changes regarding the data submitted on or attached to the Form 2A prior to passing the Oil and Gas Location Assessment (OGLA).

1. Distance to surface water: A review of aerial photos and topographic maps indicate that there is a surface water feature located approximately 650 feet east of the proposed location.
 - The distance to surface water should be changed to 650 feet.
2. Multi Well Plan: Due to two well being placed on the pad the COGCC requires that a multi well plan be provided. The plan should show both the well head location and bottom hole location. Further information regarding multi well plans can be found in COGCC rule 303.d.3.I.
