Flare stack will be removed after a gas line is installed. One of the two heater treaters will be removed when production volumes fall below the capacity of a single heater treater. Depth to groundwater determined from Water Well Permit #79435, which is the closest well with depth to groundwater information. This water well lies to the southeast of the location in Section 7, T4N-R62W. The closest water well lies 16050 feet southeast of the location, as shown on Figure 5.
