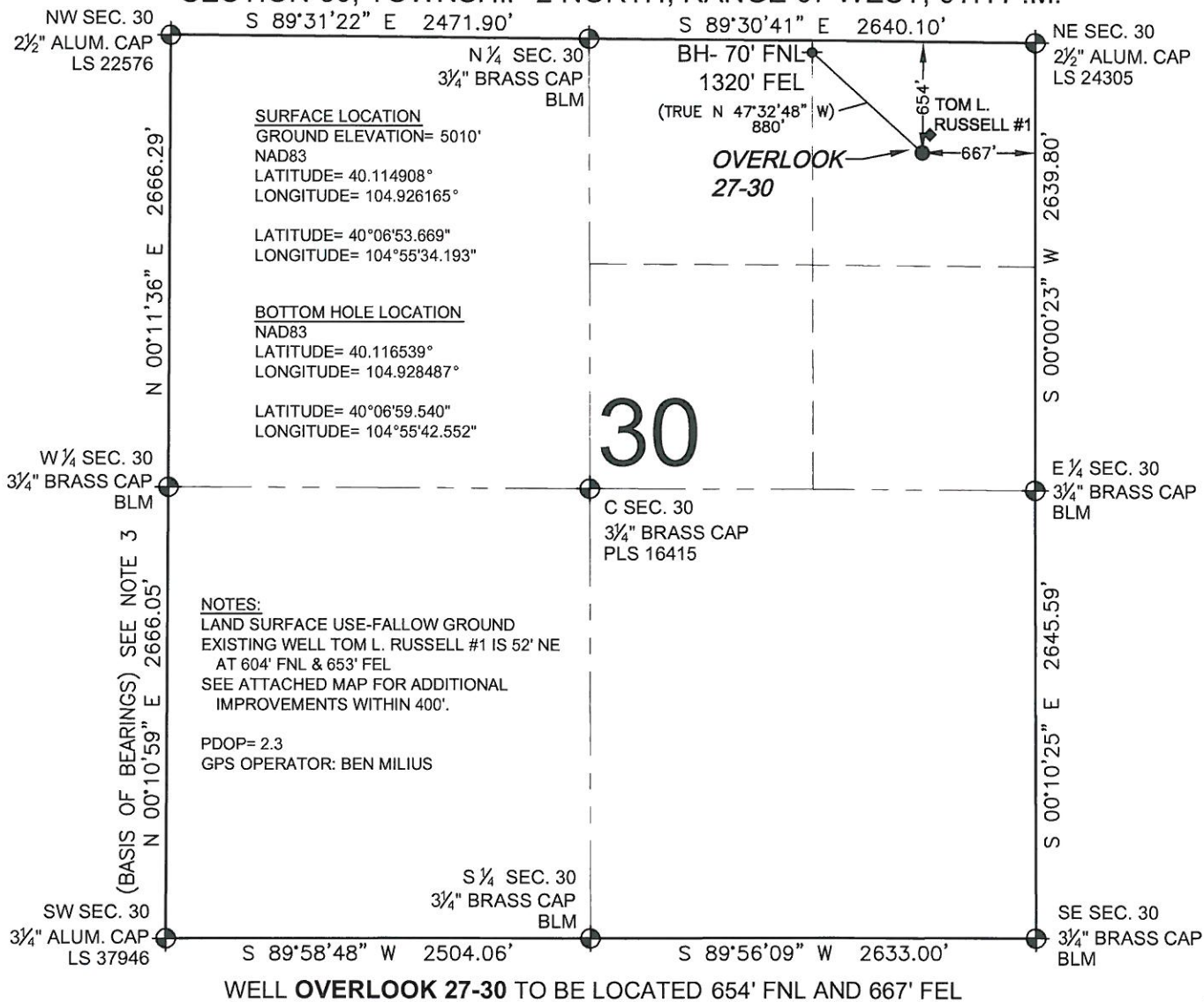


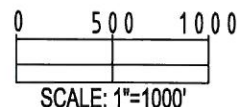
WELL LOCATION CERTIFICATE: OVERLOOK 27-30
