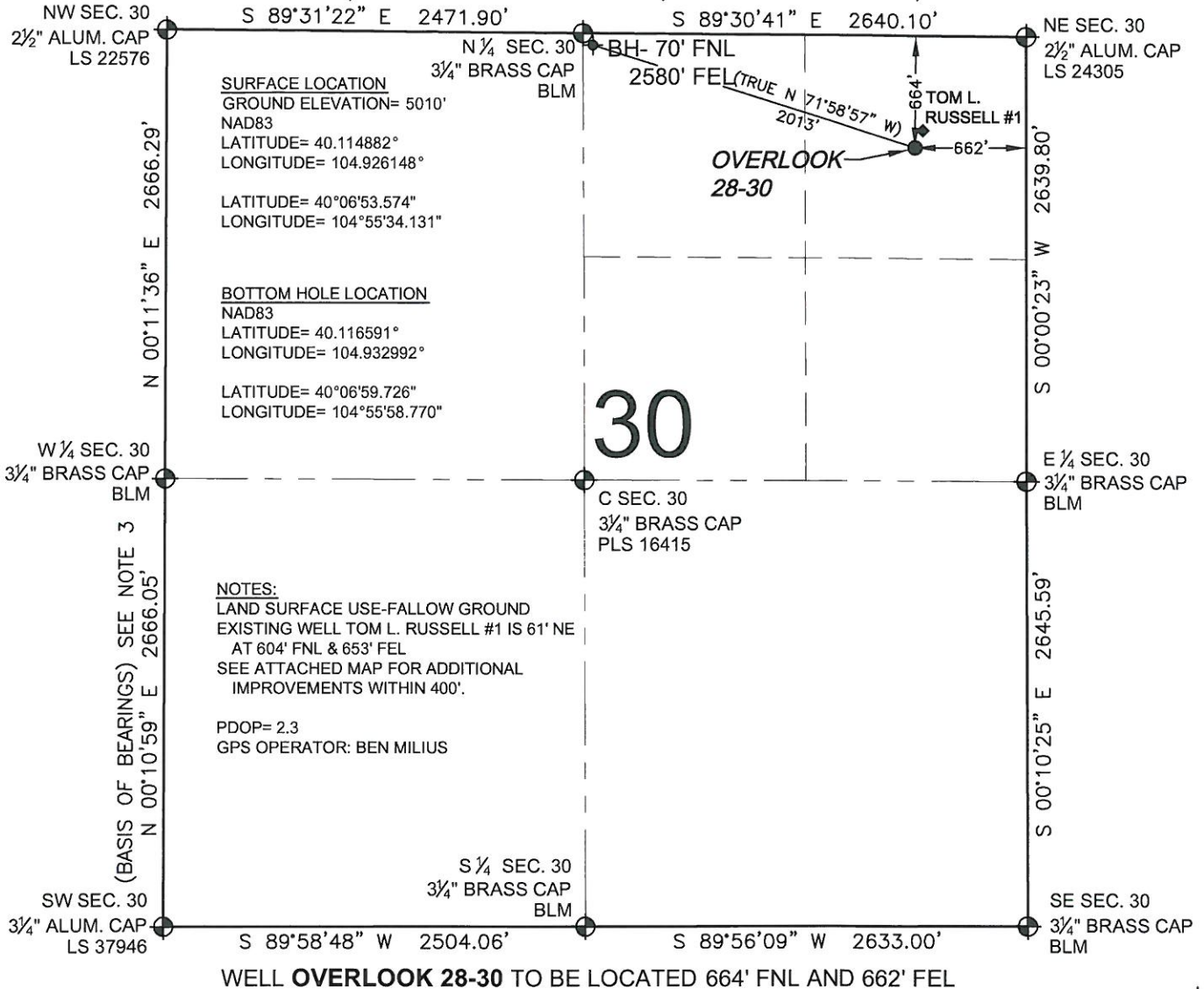


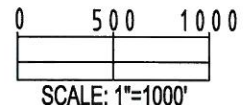
WELL LOCATION CERTIFICATE: OVERLOOK 28-30

● = PROPOSED WELL ⊕ = EXISTING WELL

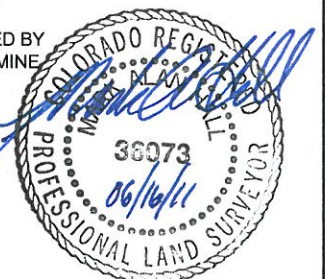
