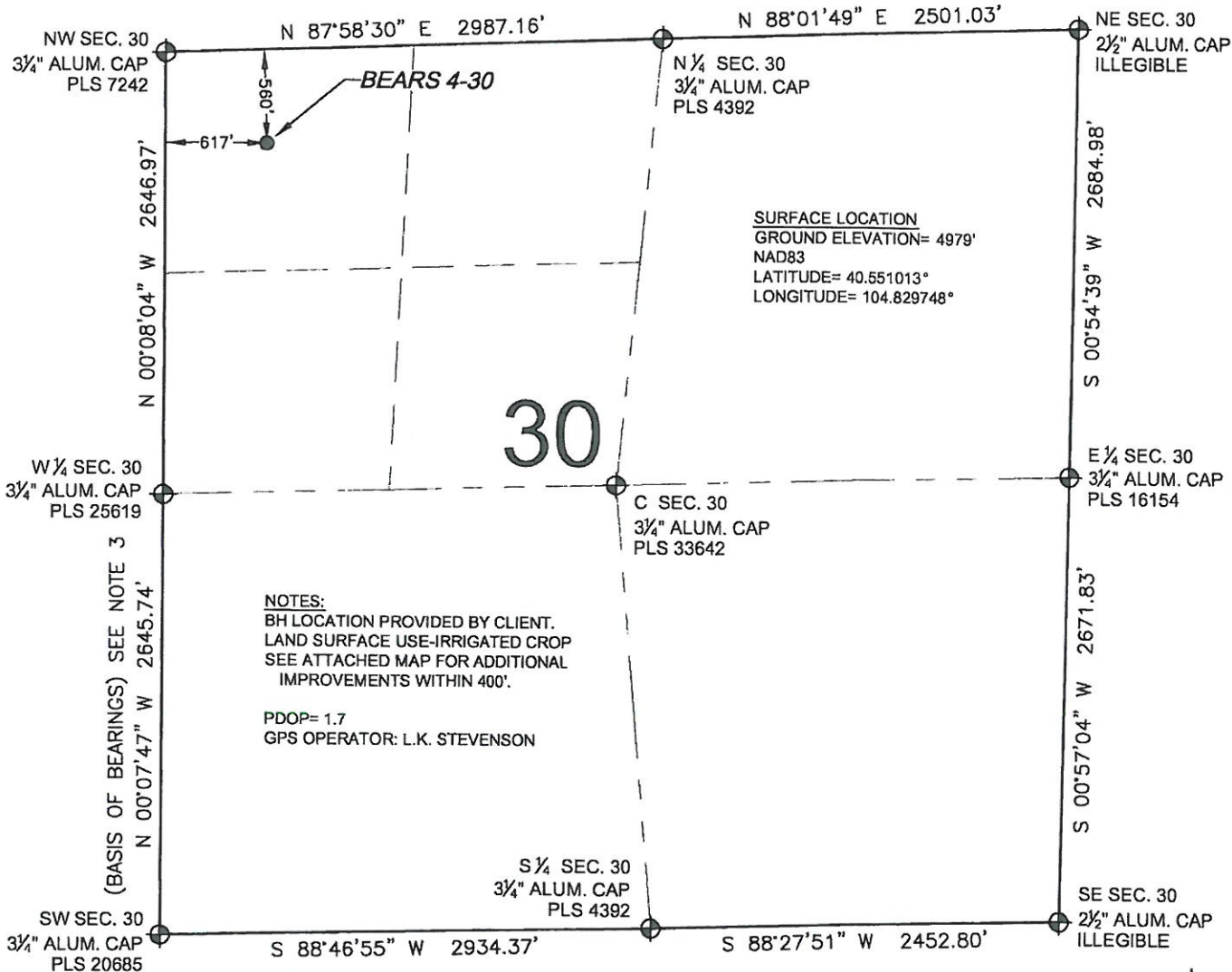


WELL LOCATION CERTIFICATE: BEARS 4-30

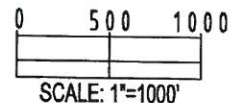
SECTION 30, TOWNSHIP 7 NORTH, RANGE 66 WEST, 6TH P.M.
