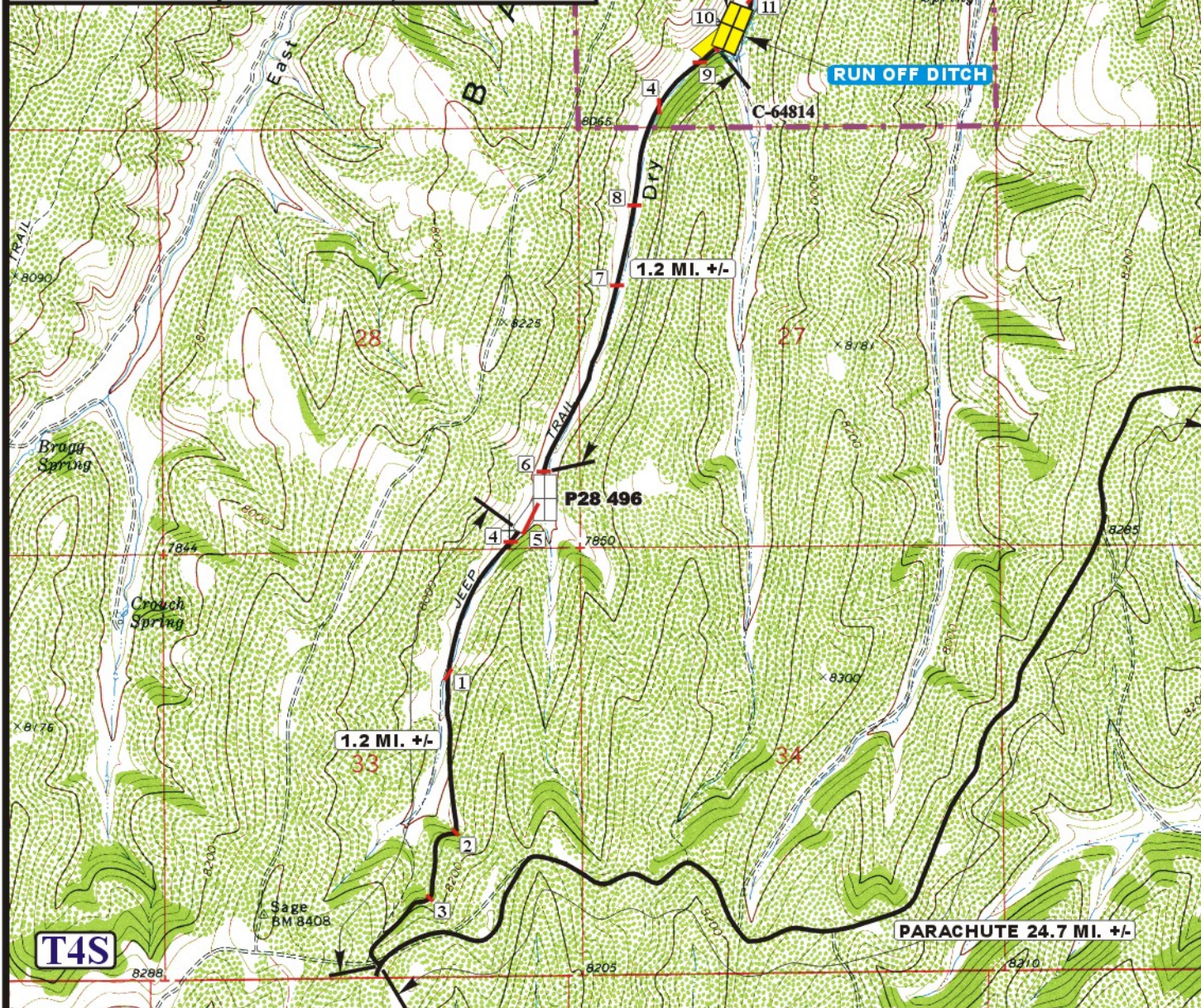

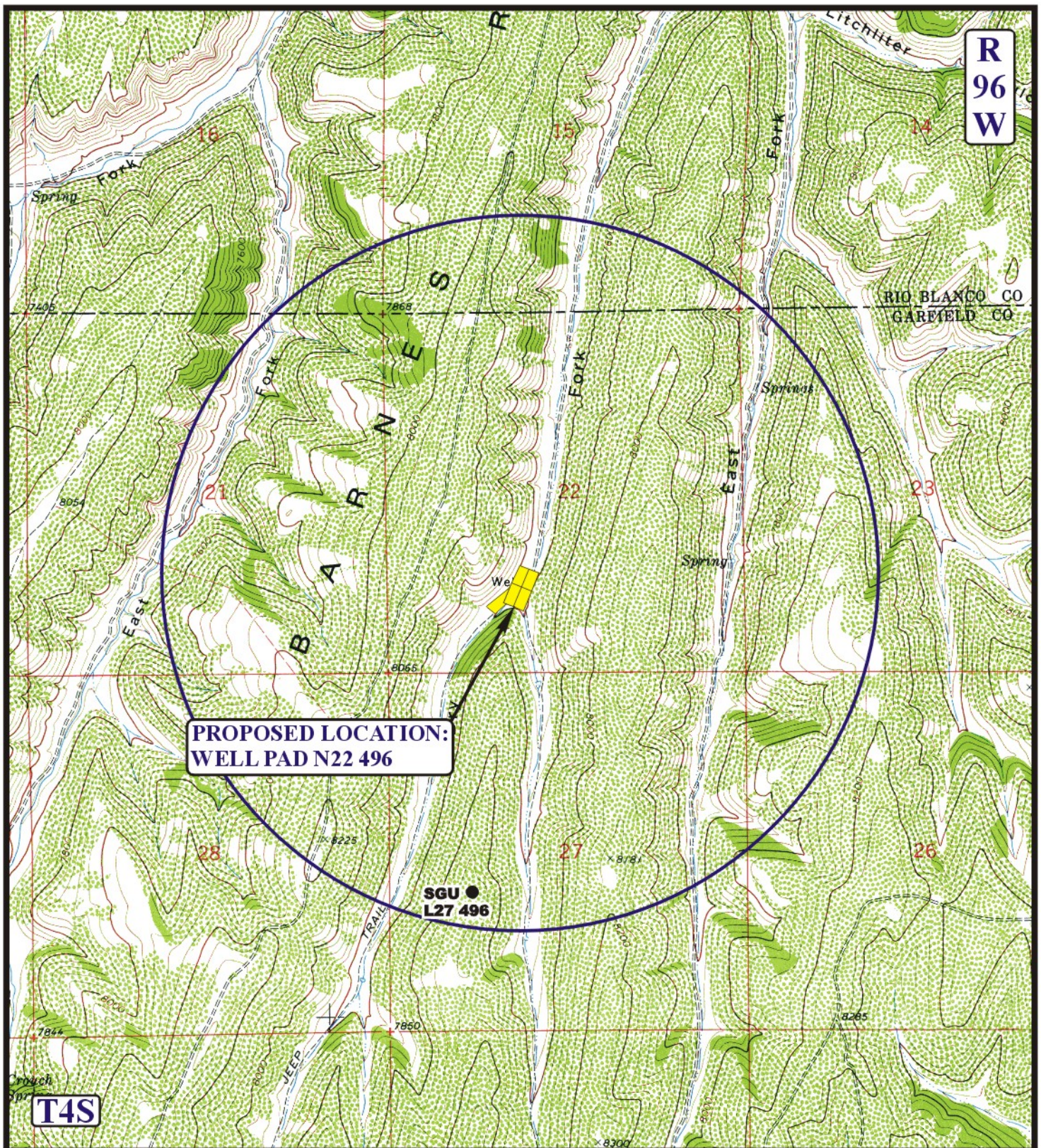

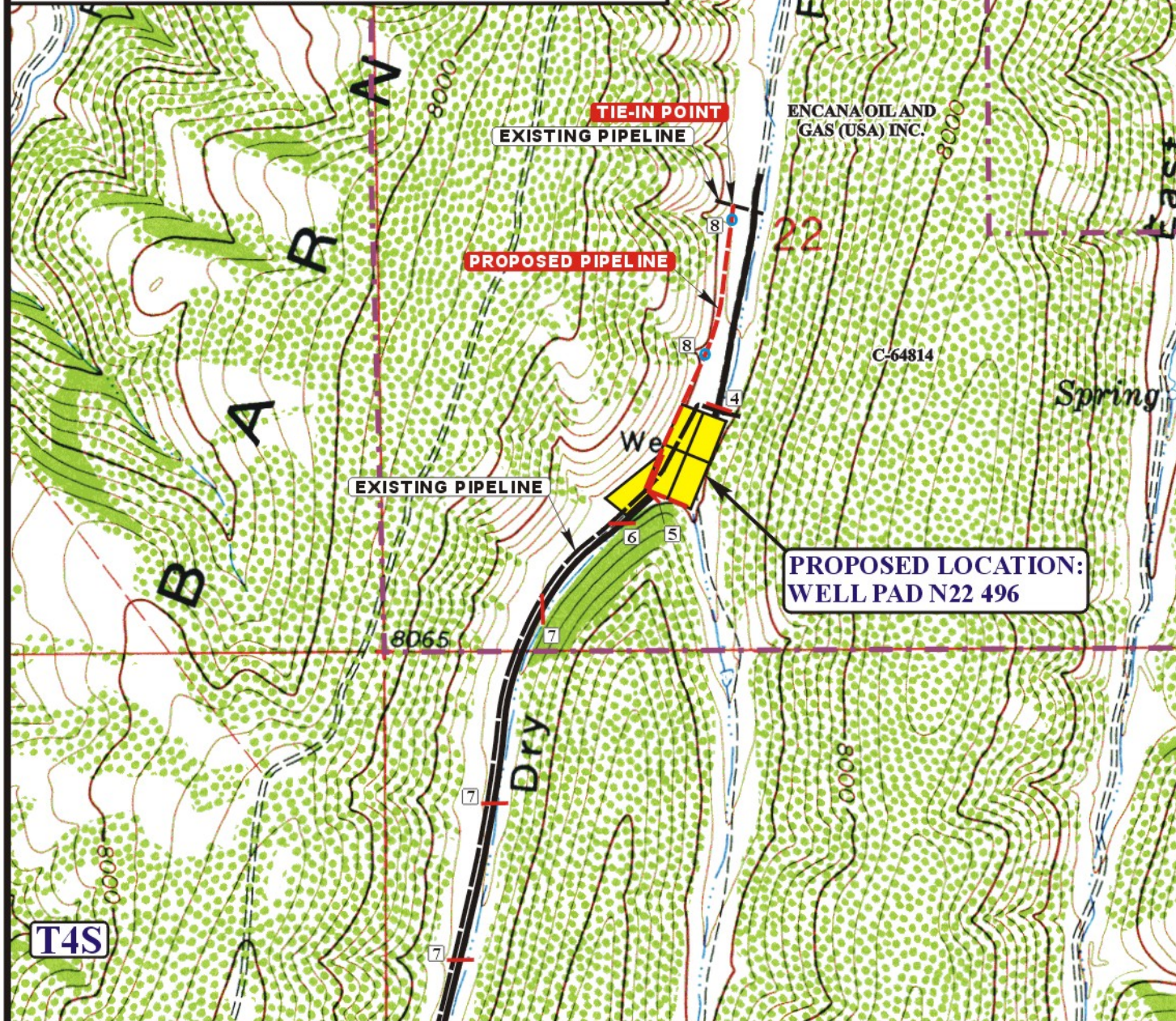

PROCEED IN A NORTHWESTERLY DIRECTION FROM PARACHUTE, COLORADO ALONG COUNTY ROAD 215 APPROXIMATELY 10.8 MILES TO THE JUNCTION OF THIS ROAD AND AN EXISTING ROAD TO THE NORTHWEST; TURN LEFT AND PROCEED IN A NORTHWESTERLY DIRECTION APPROXIMATELY 10.0 MILES TO THE JUNCTION OF THIS ROAD AND AN EXISTING ROAD SOUTHWEST; TURN LEFT AND PROCEED IN A SOUTHWESTERLY DIRECTION APPROXIMATELY 3.9 MILES TO THE JUNCTION OF THIS ROAD AND AN EXISTING ROAD TO THE NORTHWEST; TURN RIGHT AND PROCEED IN A NORTHWESTERLY, THEN NORTHERLY DIRECTION APPROXIMATELY 1.2 MILES TO THE P28 496 AND JUNCTION OF THIS ROAD AND AN EXISTING ROAD TO THE NORTHEAST; PROCEED IN A NORTHEASTERLY DIRECTION APPROXIMATELY 1.2 MILES TO THE PROPOSED LOCATION.

TOTAL DISTANCE FROM PARACHUTE, COLORADO TO THE PROPOSED WELL LOCATION IS APPROXIMATELY 27.1 MILES.
