Provide a detailed description of the accident, problem, and cause (equipment failure, human error, etc.):

On the morning of May 24, 2011, Renegade received a phone call from the Rattlesnake Fire Department saying they were on the above location and that the crude oil tank had been hit by lightning and was on fire. Severe thunderstorms were rolling through the area that morning.

Rattlesnake said that they did not have the proper chemical needed to extinguish the fire.

We dispatched people to the tank battery and reached the Bennett Fire Department by phone to confirm that they did have the proper chemical and they were dispatched to the tank battery.

The Bennett and Rattlesnake Fire Departments were able to extinguish the fire within 2-3 hours of notification to Renegade.

No oil was released or spilled, and approximately 12 barrels of oil was burned in the fire.

The balance of the oil was transferred to another tank battery and subsequently sold.
