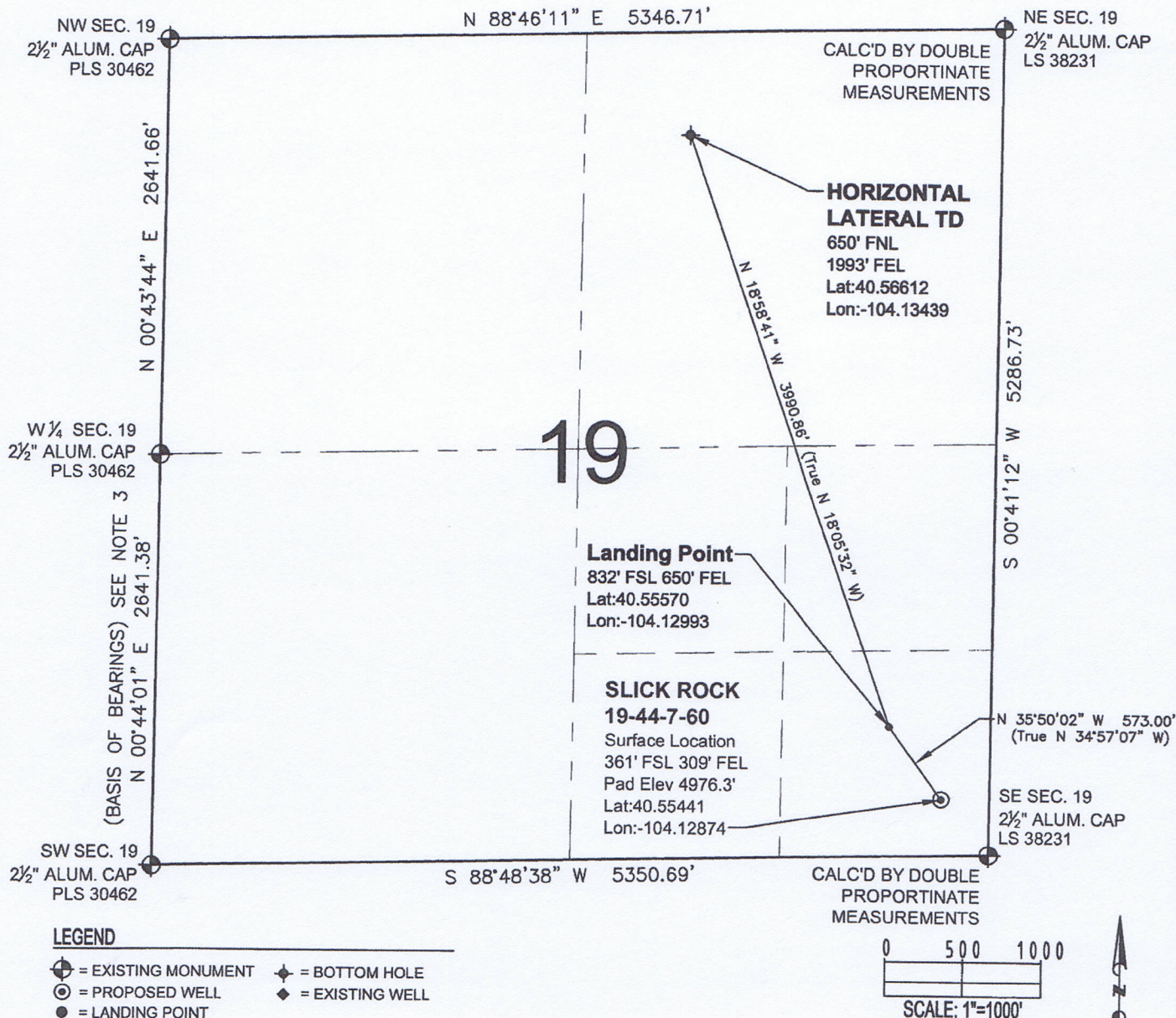


WELL LOCATION CERTIFICATE
