Yuma County Assessor records indicate you own the surface of the captioned lands. Colorado Oil and Gas Conservation Commission (COGCC) Rule 305.e. (1).B requires that you be given thirty (30) days advance notice of planned oil and gas operations on the captioned lands.

In accordance with Rule 305.e.(1).B please be advised that Noble Energy, Inc.
