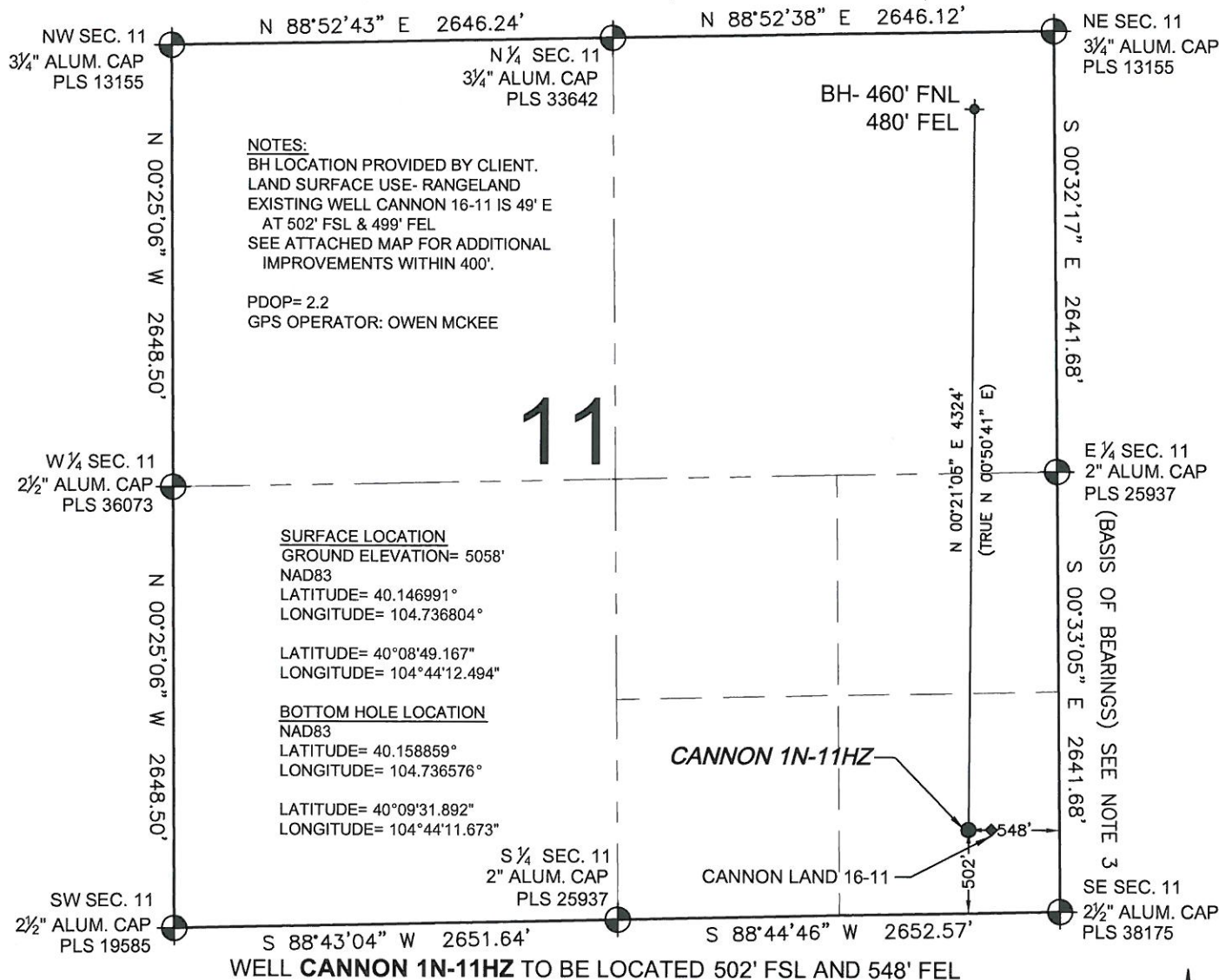


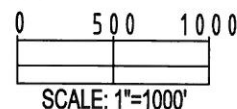
WELL LOCATION CERTIFICATE: CANNON 1N-11HZ

● = PROPOSED WELL ◆ = EXISTING WELL

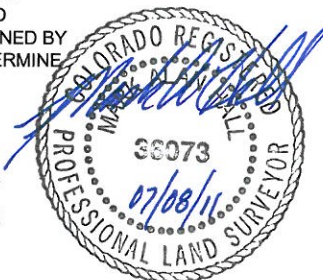
