Hi Kallasandra,

The COGCC is reviewing the Form 2A oil and gas location assessment for the IRVINE FACILITY 15-22 location in the SWSE Sec22 T7N R64W, Weld County, and requests the following additional information to complete the review of the Form 2A:

- 1) **Mud Disposal:** COGCC has deleted the mud disposal method since no drilling will be conducted at this location. That is fine (I was under the impression that it was a requirement during the validation to have it filled out. I will make sure it is not going forward.)
- 2) **Land Use:** Based on a review of aerial photography and the Location Pictures, the land use appears to be Non-Crop Land – Rangeland. COGCC will change the Form 2A to state that the Current and Future Land Use is Rangeland. That is fine.
- 3) **Plant Community:** Since the land use is rangeland, please provide me with information necessary to complete the Plant Community section of the Form 2A, including whether noxious weeds are present.

- 4) **Reference Area:** Please provide Reference Area Pictures and a Reference Area Map to document the Reference Area selected for reclamation purposes. Attached
