Hi John:

Attached please find a Form 27 and supporting documentation for activities associated with a release attributed to a tank weld failure at the above referenced subject site located in the C/SW Section 35-T7N-R66W. Soils and groundwater were impacted at the site from the release. Approximately 440 cubic yards of impacted soil and 180 barrels of impacted groundwater were removed from the site and transported to a licensed facility for disposal. Groundwater monitoring wells were installed and sampled. Initial samples indicated that BTEX levels in the monitoring wells were below CDPHE WQCD Regulation 41 limits. PDC will continue to monitor groundwater concentrations until four consecutive quarters of groundwater concentrations are compliant.
