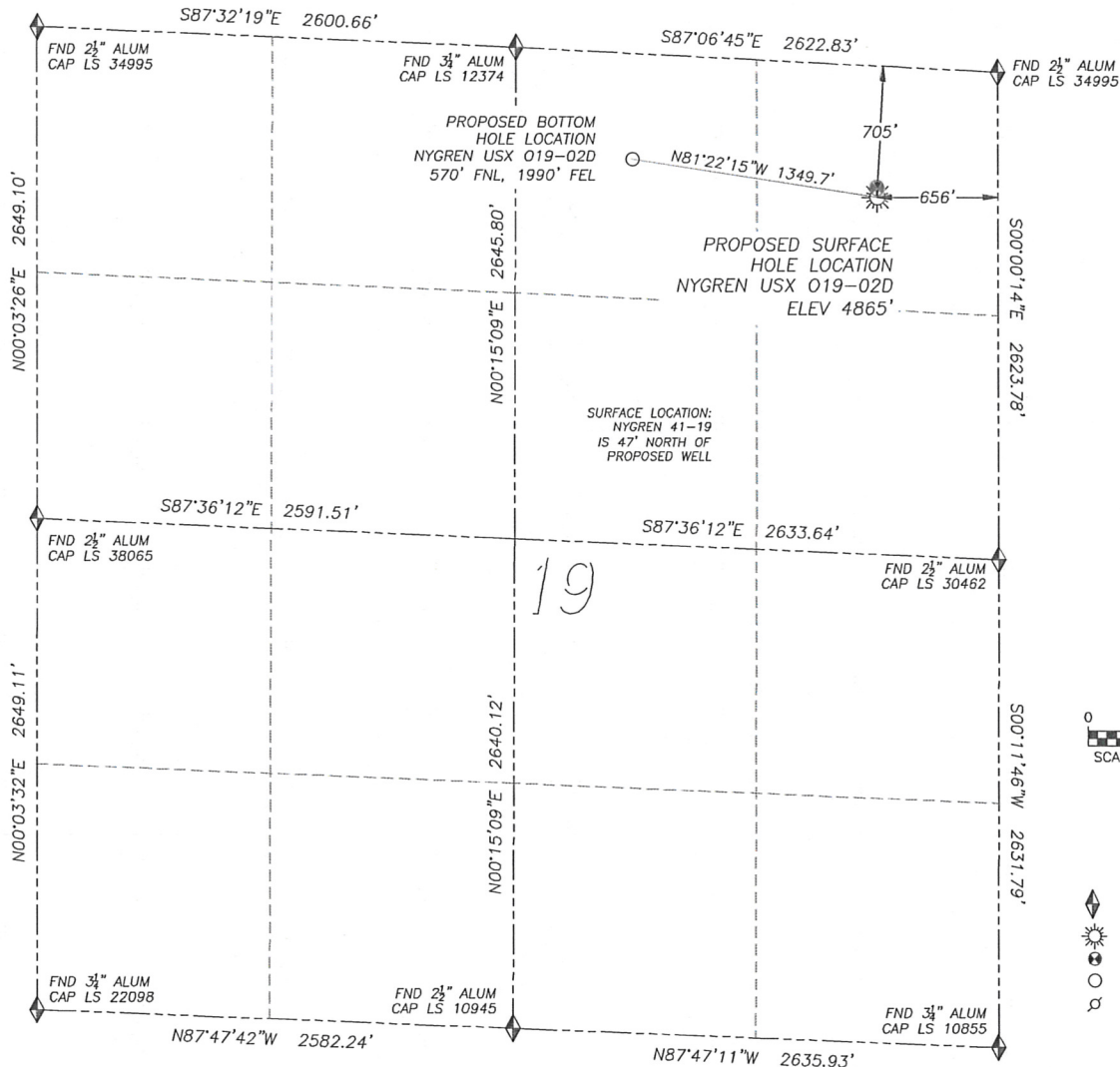

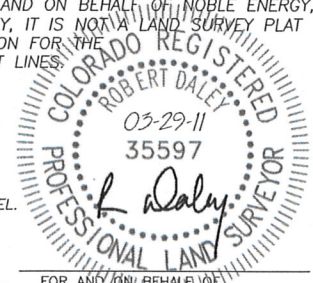

THE BOTTOM HOLE LOCATION, PROVIDED BY THE CLIENT, IS TO BE 570' FNL, 1990' FEL.

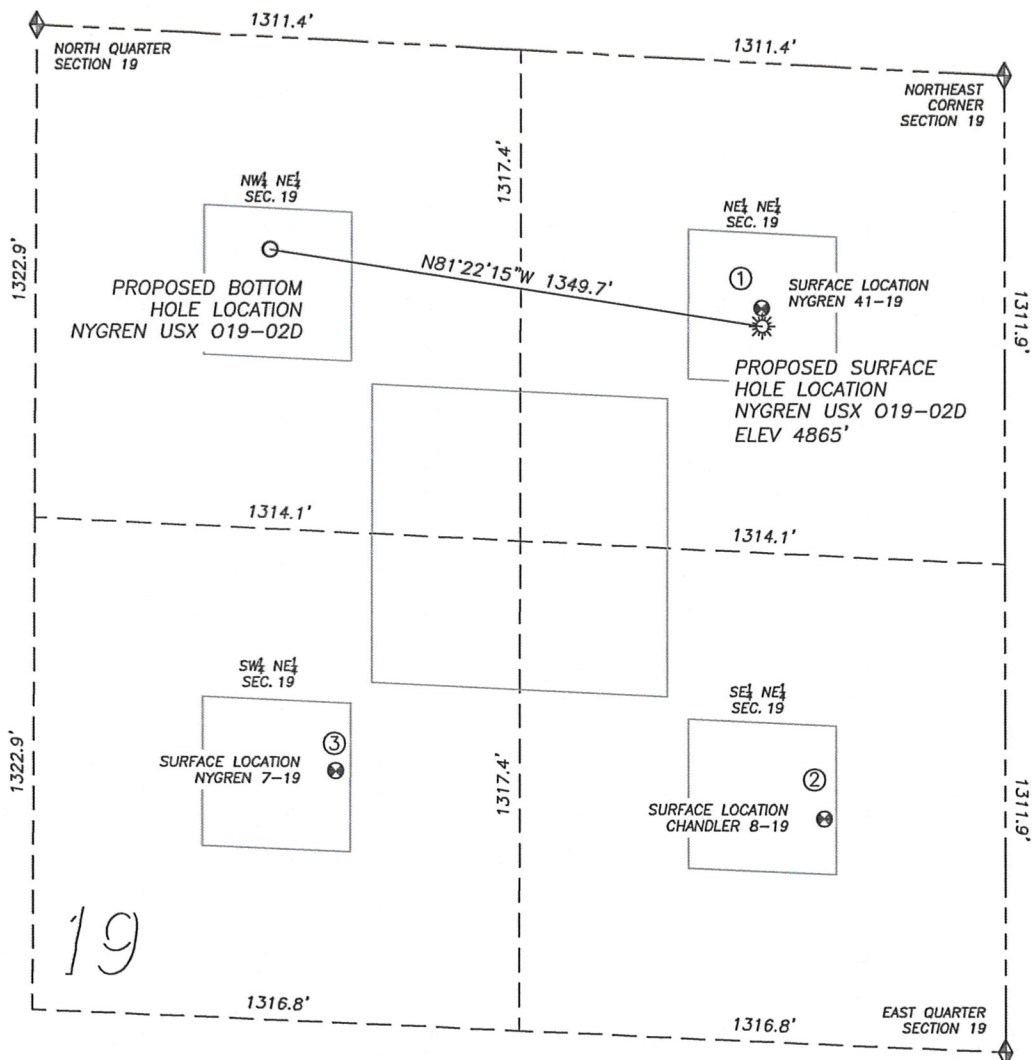
