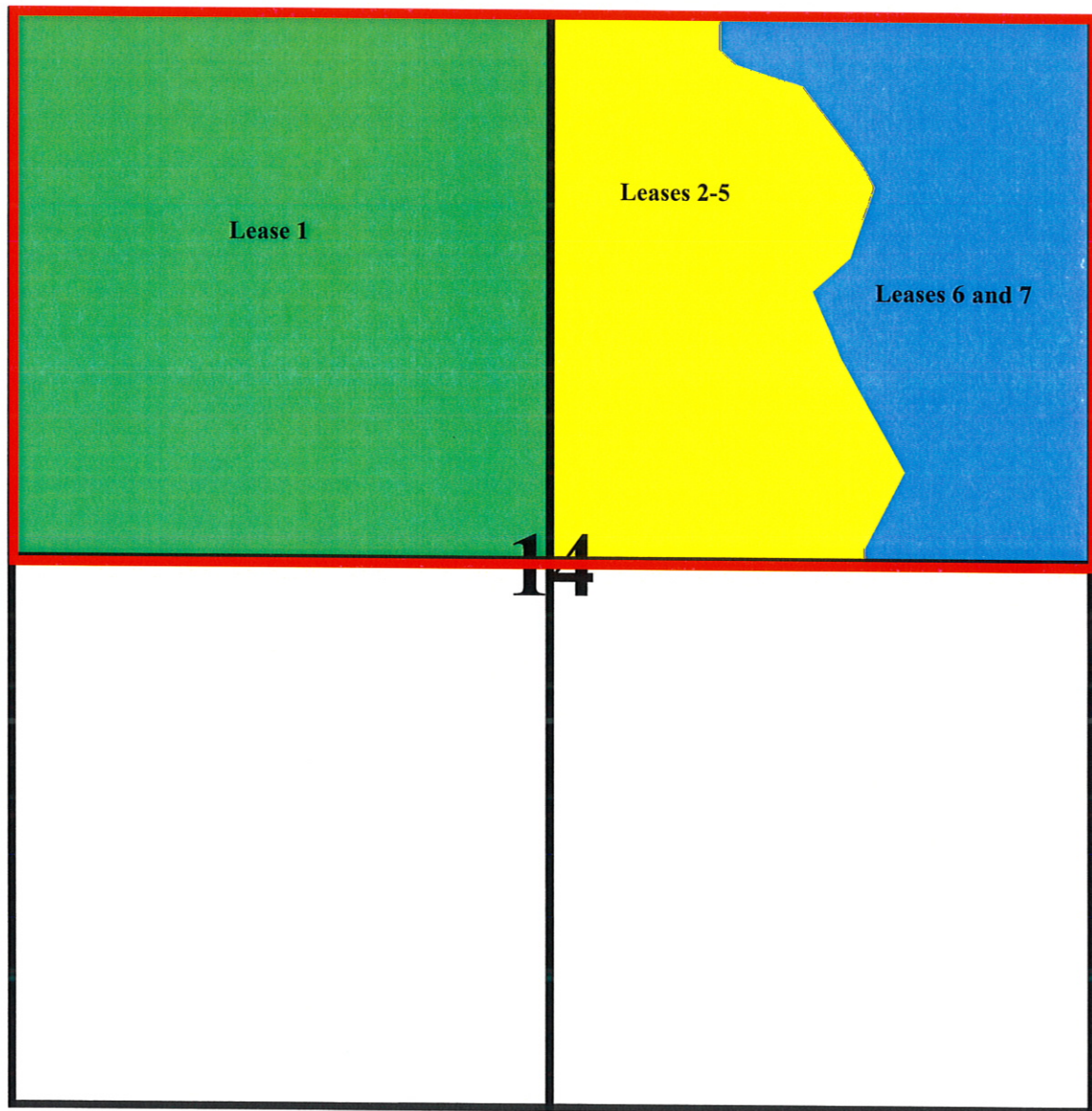


Lease Map – Rayglo A14-68-1HN
