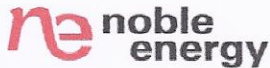

In accordance with Rule 305.e.(1).B please be advised that Noble Energy, Inc. ("Noble") plans to commence operations with heavy equipment for the drilling of the captioned well at such time it receives a permit therefore.
