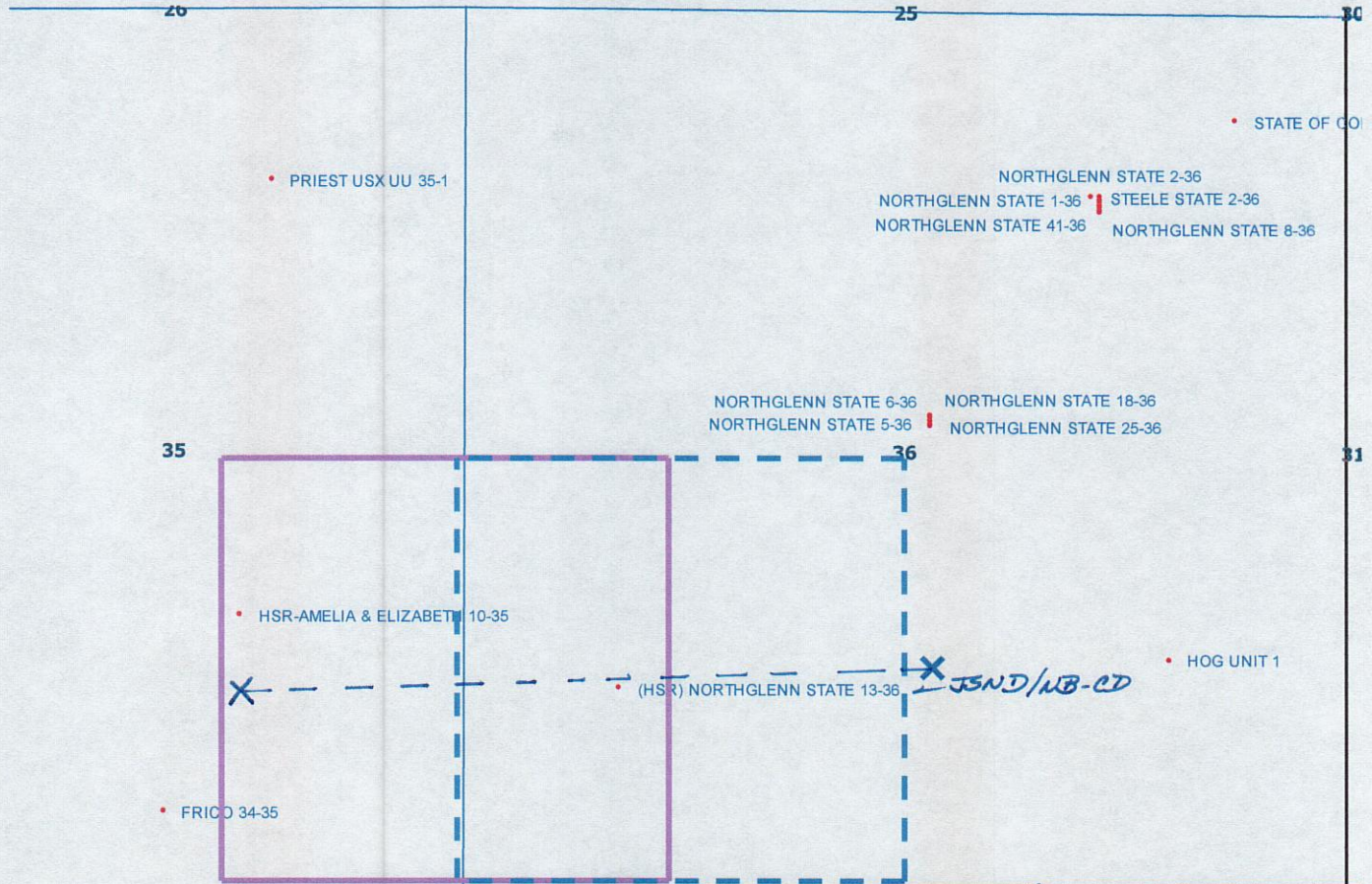

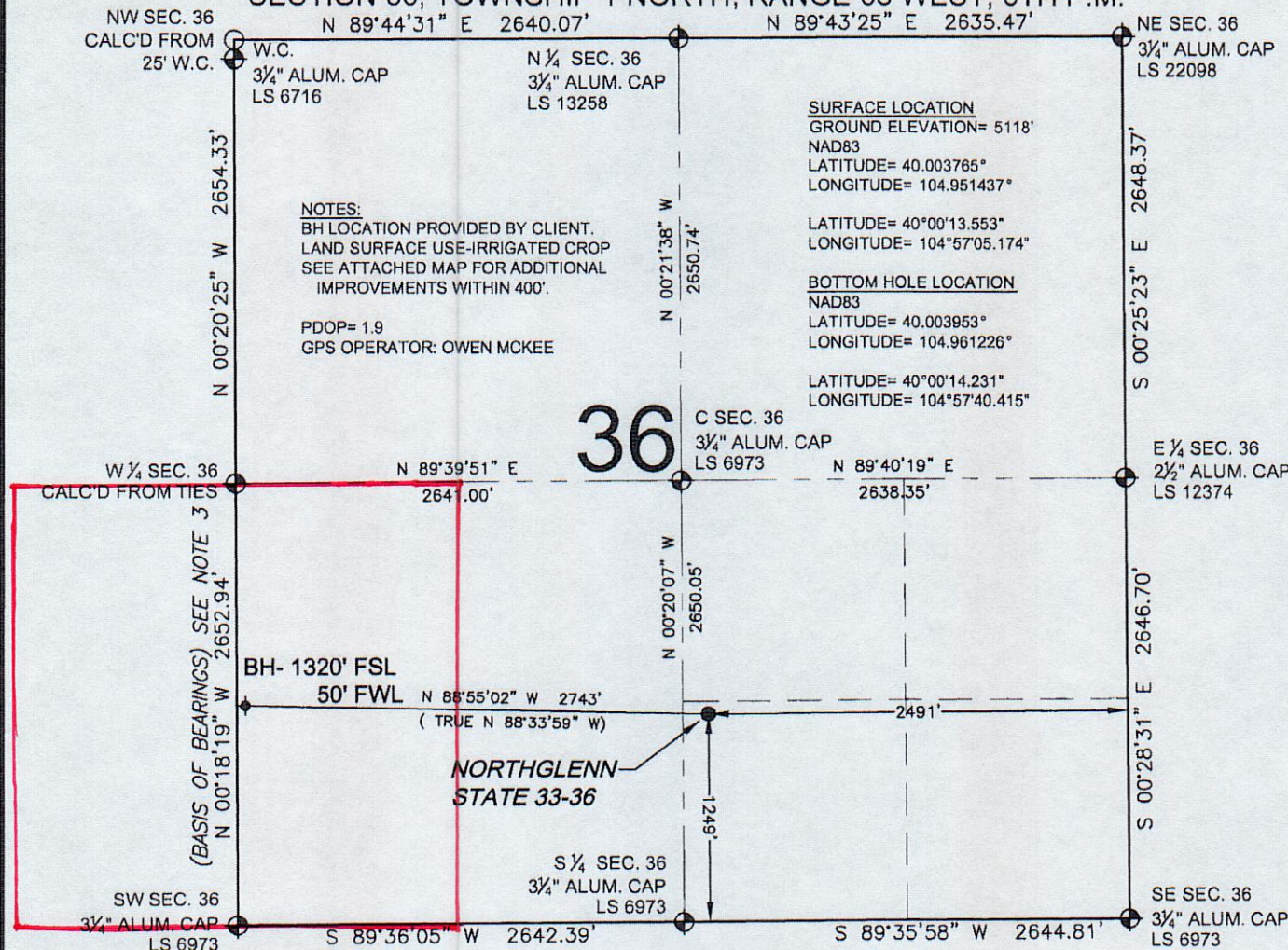
Proposed 160 acre Spacing Unit (Solid line).

This 1/4 Section has less than 8 bottom hole wells producing from the Codell, Niobrara & J Sand Formations.

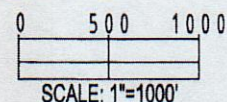

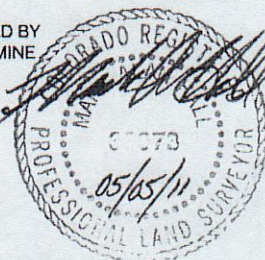
