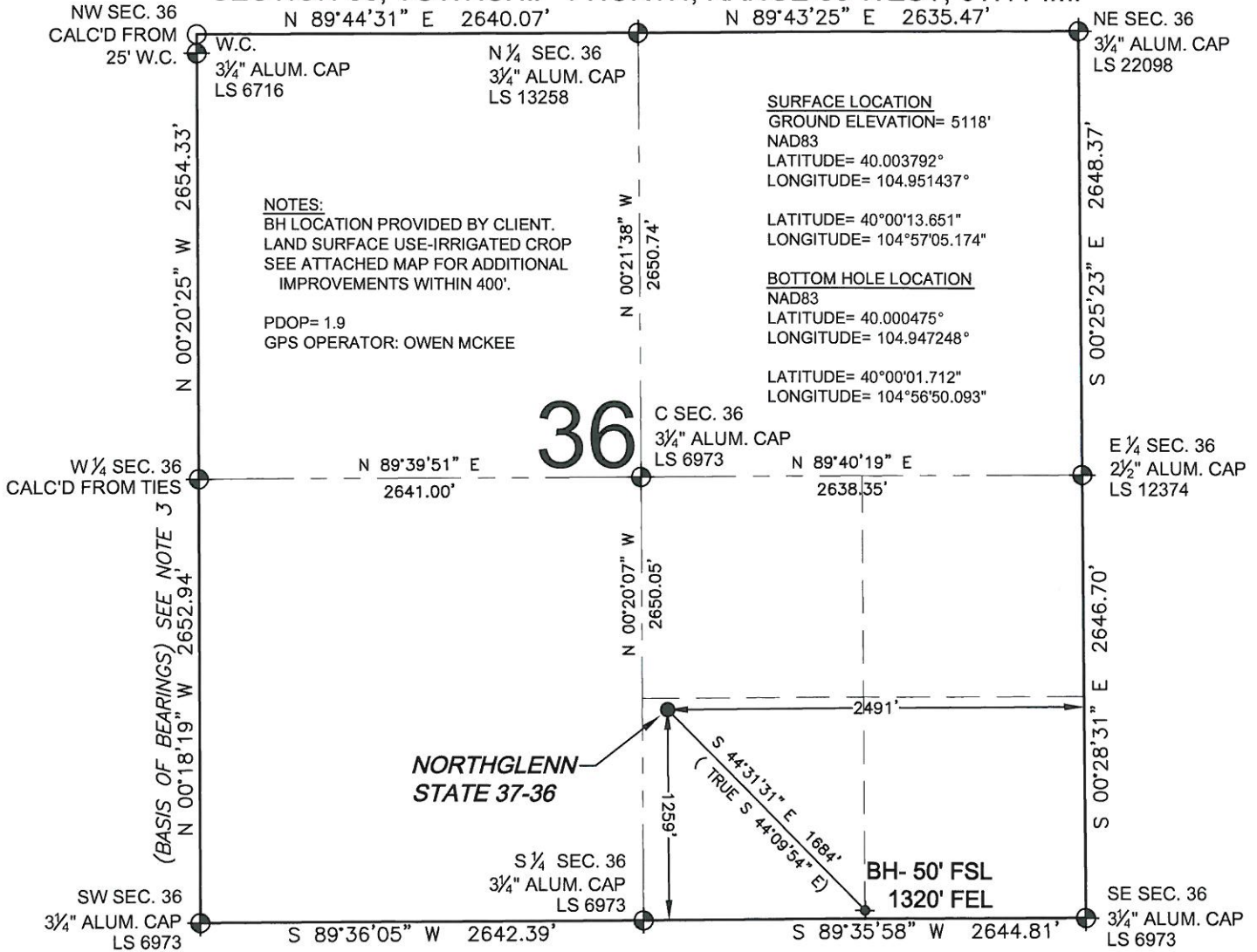


WELL LOCATION CERTIFICATE: NORTHGLENN STATE 37-36
