Nearest building is a pump house for the Adena Unit water injection system. Nearest above ground utility is the power line to the Glenn Biddle B-3 well. Nearest railroad is in Fort Morgan. Nearest surface water is Badger Creek. Depth to ground water in the nearest water well (40') is based on depth to perfs in the water well, because no static water level is reported for the water well (permit 17757--, receipt 9048052). The reclamation reference area is immediately adjacent to and west of the planned facility. Location reference point is the planned location of the separator (see location drawing).
