I have sent the above form back to draft. Please make the following corrections before resubmitting the form.

- The location of the well bore does not match up with the mineral lease you provided in #23.
- For number 22 if the surface owner is not the mineral owner how is there signature on the lease? Please note that if the surface owner is a partial mineral owner then you can put yes for #22.
- If you plan on bonding on please select \$25,000 Blanket for #22b and select No for #22a.
