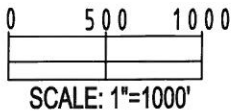
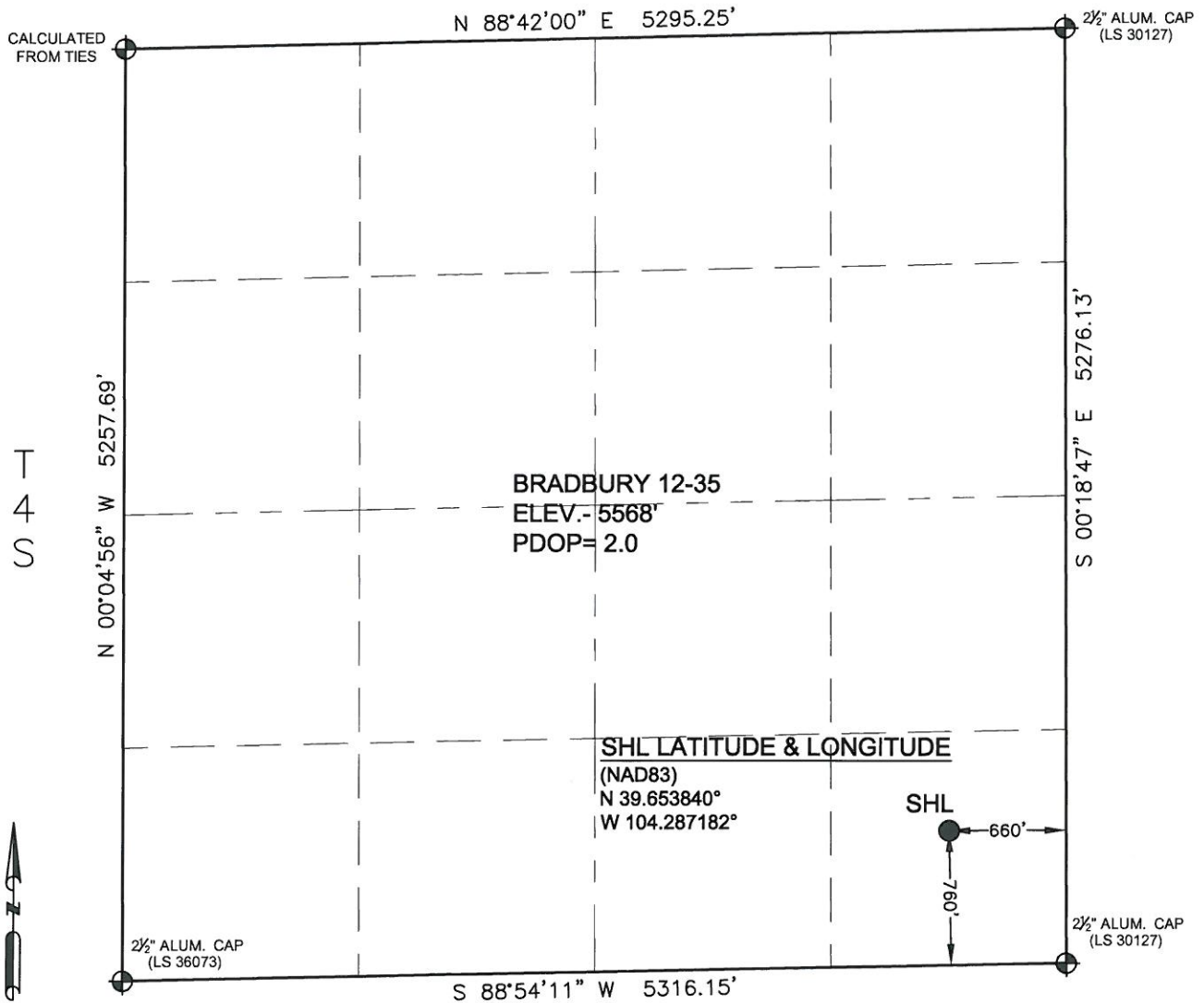


WELL LOCATION CERTIFICATE
