At this time, DOE does not request any additional information but would encourage COGCC to place general language in the permit such that the company would accommodate DOE sampling requests in the future. DOE agrees with the COGCC assessment that the bottom-hole-locations range from 2.58 to 2.81 miles from Project Rulison, and that all wells fall under the Tier 2, Sector 10 sampling and monitoring of the COGCC Rulison Sample and Analysis Plan. DOE will continue to review the proposed locations and subsurface orientations of the propose drilling for documentation when sampling occurs. Encana has submitted 5 FORM 2's APD for wells within the Project Rulison 3 mile radius.

The surface location is located just outside the 3 mile radius in Lot 3, Sec. 28-T7S-R95W, latitude 39.415586, longitude -108.003227.

The BHL's range from 2.81 miles to 2.58 miles from the project well and are located in the NE/4, Sec. 28-T7S-R95W.

These locations are in Tier 2 of the Rulison SAP.
