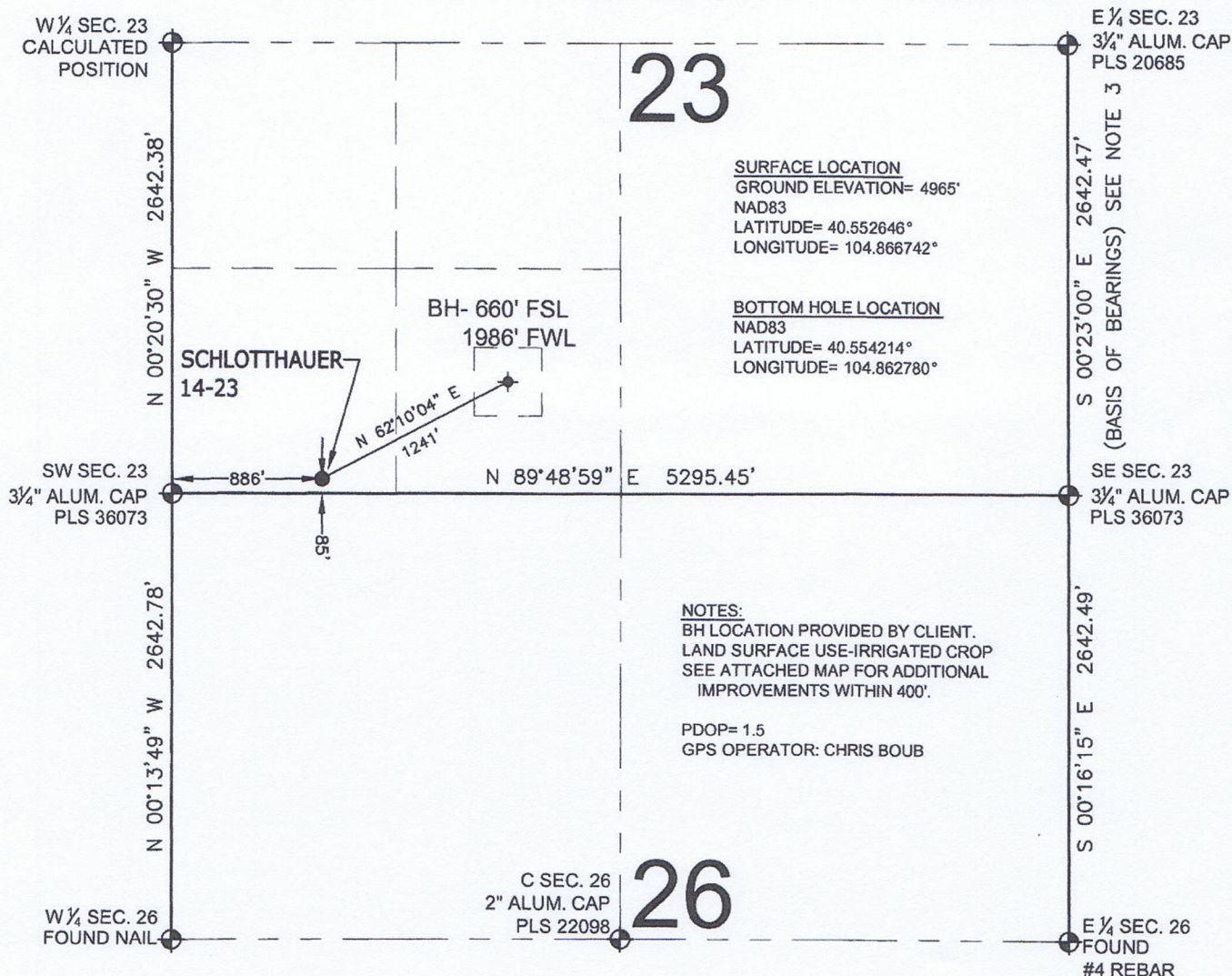


WELL LOCATION CERTIFICATE: SCHLOTTHAUER 14-23

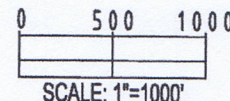
SECTION 23, TOWNSHIP 7 NORTH, RANGE 67 WEST, 6TH P.M.
