Black Raven Energy is requesting Expedited Approval of Forms 2 & 2A (Rule 303.1) due to exigent circumstances and therefore has attached a copy of the surface owner waiver as part of this application. Railroad is 1.11 +/- miles from site. There are no visible improvements within 400 feet of site. Nearest water well is 3532 +/- feet from site (Receipt - 9053915, Permit 41878, Use - Domestic) There is a playa 1780 feet from site. The location is in a sensitive area due to being in the Northern High Plain Designated Basin. No COA's are needed for this location. It may be necessary to place a pumping unit on the facility at some point in the future to aid with gas production. It will require either one gas or one electric motor to run the unit.
