Proposed Procedure:

- 1 POOH w/ 2-3/8" tbg
- 2 RIH set RBP and packer and identify high water producing zone
- 3 POOH w/ packer and tubing
- 4 RIH and remediate high water producing zone with Class G cement
- 5 POOH w/ down hole equipment
- 6 Drill out cement and test to 1500 psi
- 7 RIH with tubing and return to production
