Notice of Alleged Violation Requested Information

Dear Mr. Labowski:

As follow-up to our meeting of December 8, 2011 concerning the NOAV issued September 6, 2011, I have enclosed documentation of the process used to ensure that herbicide use for well pad weed control is discontinued at the Hester 1. Additionally, I installed a "No Weed Spraying" sign at the gate to the well pad to accommodate literacy concerns associated with the previously mounted "No Chemical Releases" sign. A photo of the gate is also attached.

As discussed during our meeting, the results of the soil sampling do not support the allegation of excessive herbicide application and any deficiencies regarding storm water control may be attributed to the berm which was installed at the behest of the complainant which undesirably concentrates flow at the southeast corner of the pad rather than allowing sheet flow off the east side of the pad. Also, the results of analysis of the Dillon water well show no evidence of herbicide or well work chemical contamination.

Please note that I revisited the issue of poor wattle installation with our planner/scheduler and was reminded that we had internally agreed to postpone wattle reinstallation pending relocation of the fencing around the location. The fencing will likely be moved closer to the working area of the pad and the wattles will be relocated within the fencing to accommodate landowner needs. Removal of the existing fencing and installation of new fencing has been delayed until we can resolve the security, safety and aesthetic issues associated with this change.

We trust that all issues listed in the NOAV have now been addressed to your satisfaction. As such, we request that the NOAV be formally rescinded in writing at your earliest convenience.
