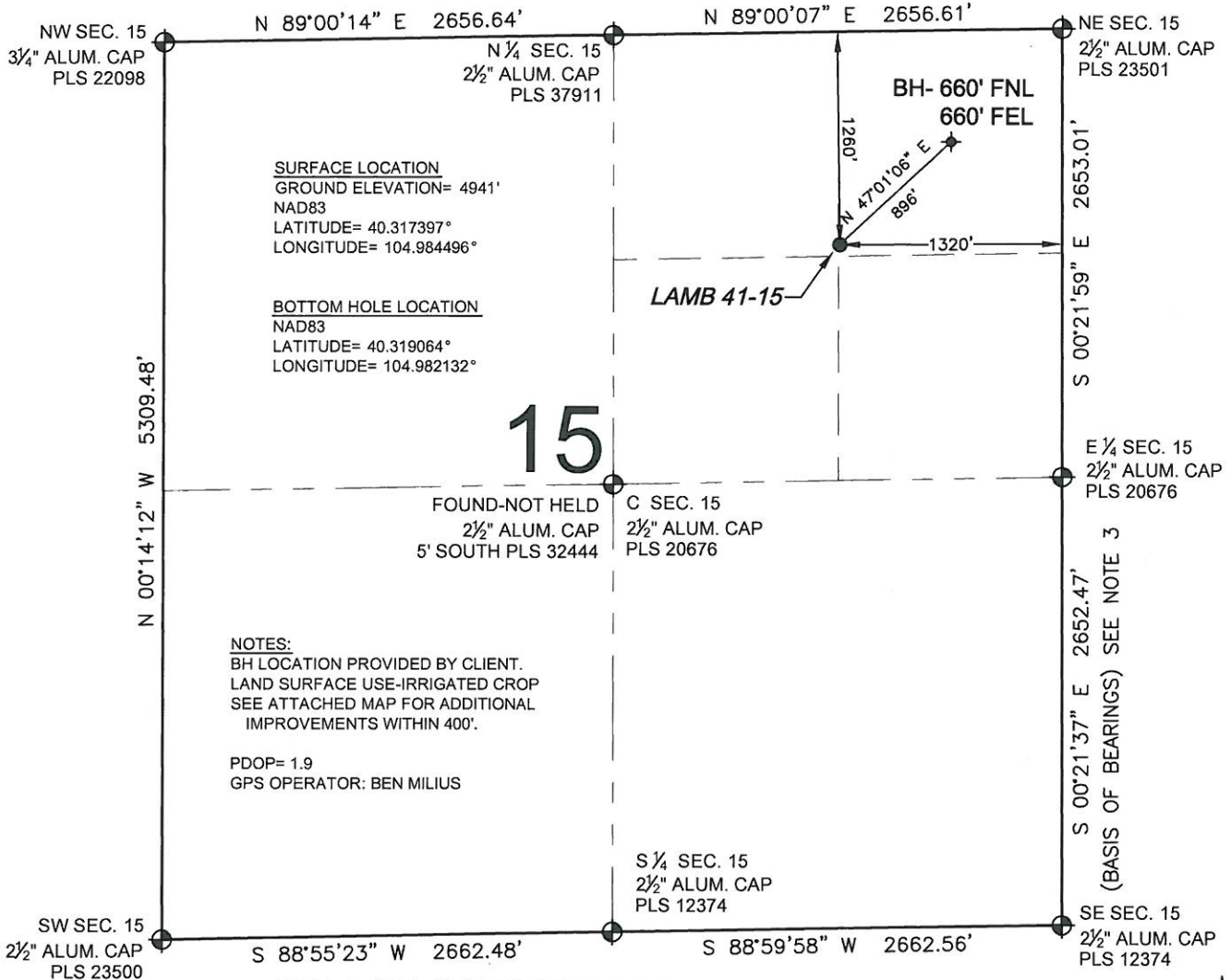


WELL LOCATION CERTIFICATE: LAMB 41-15
