At this time, DOE does not request any additional information but would encourage COGCC to place general language in the permit such that the company would accommodate DOE sampling requests in the future. DOE agrees with the COGCC assessment that the pad is located approximately 2.96 miles from the Rulison site located at NWSE Section 21-T7S-R95W. Accordingly, DOE agrees with COGCC that all wells fall under the Tier 2 sampling and monitoring of the COGCC Rulison Sample and Analysis Plan and all wells are located in Sectors 10 of the Rulison SAP. DOE will continue to review the proposed locations and subsurface orientations of the propose drilling for documentation when sampling occurs.
