Appropriate industry practices and procedures were utilized on the McLin C19 cementing program. The cement bond log indicates good zonal isolation and coverage from TD to 985'. 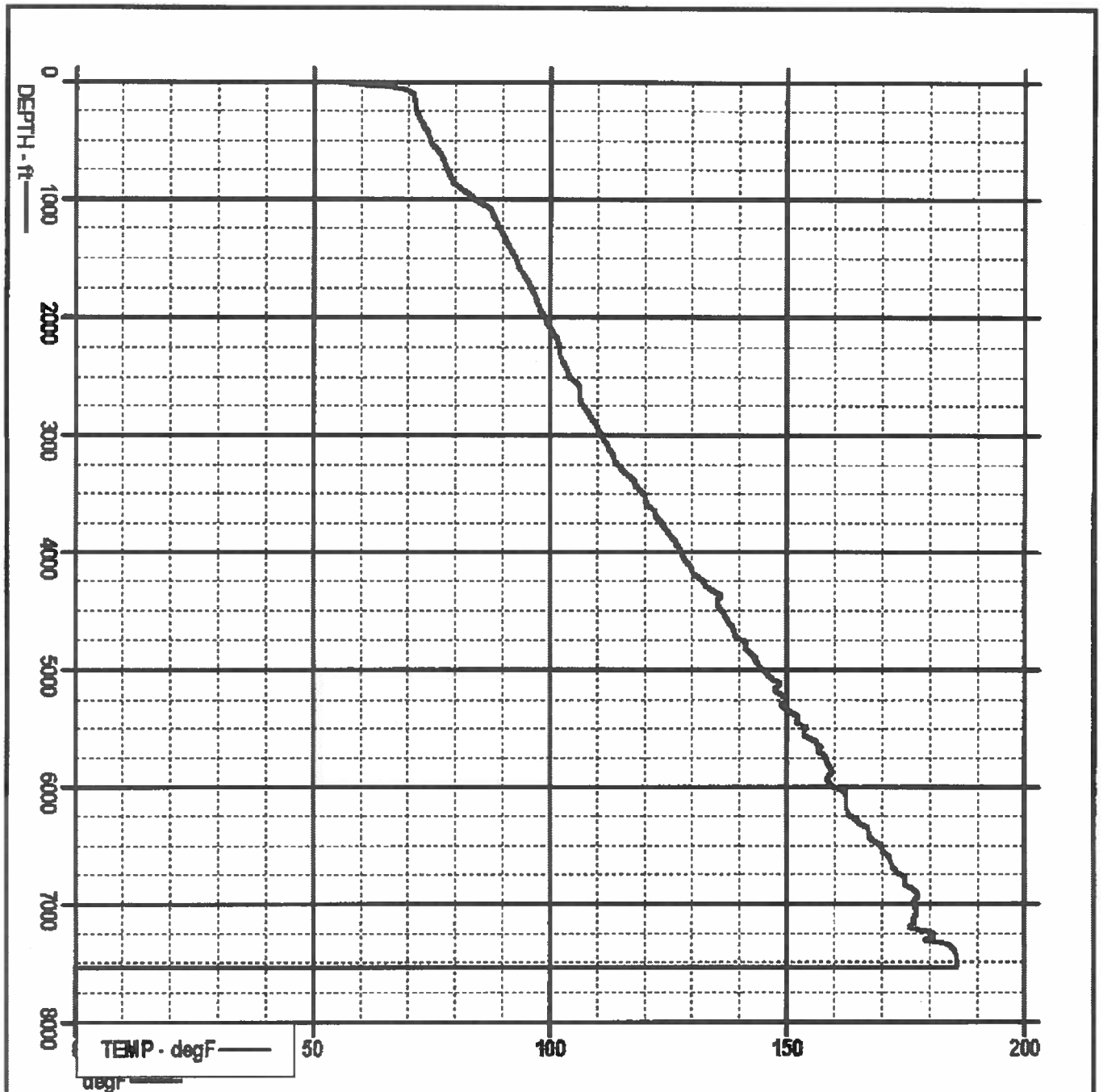

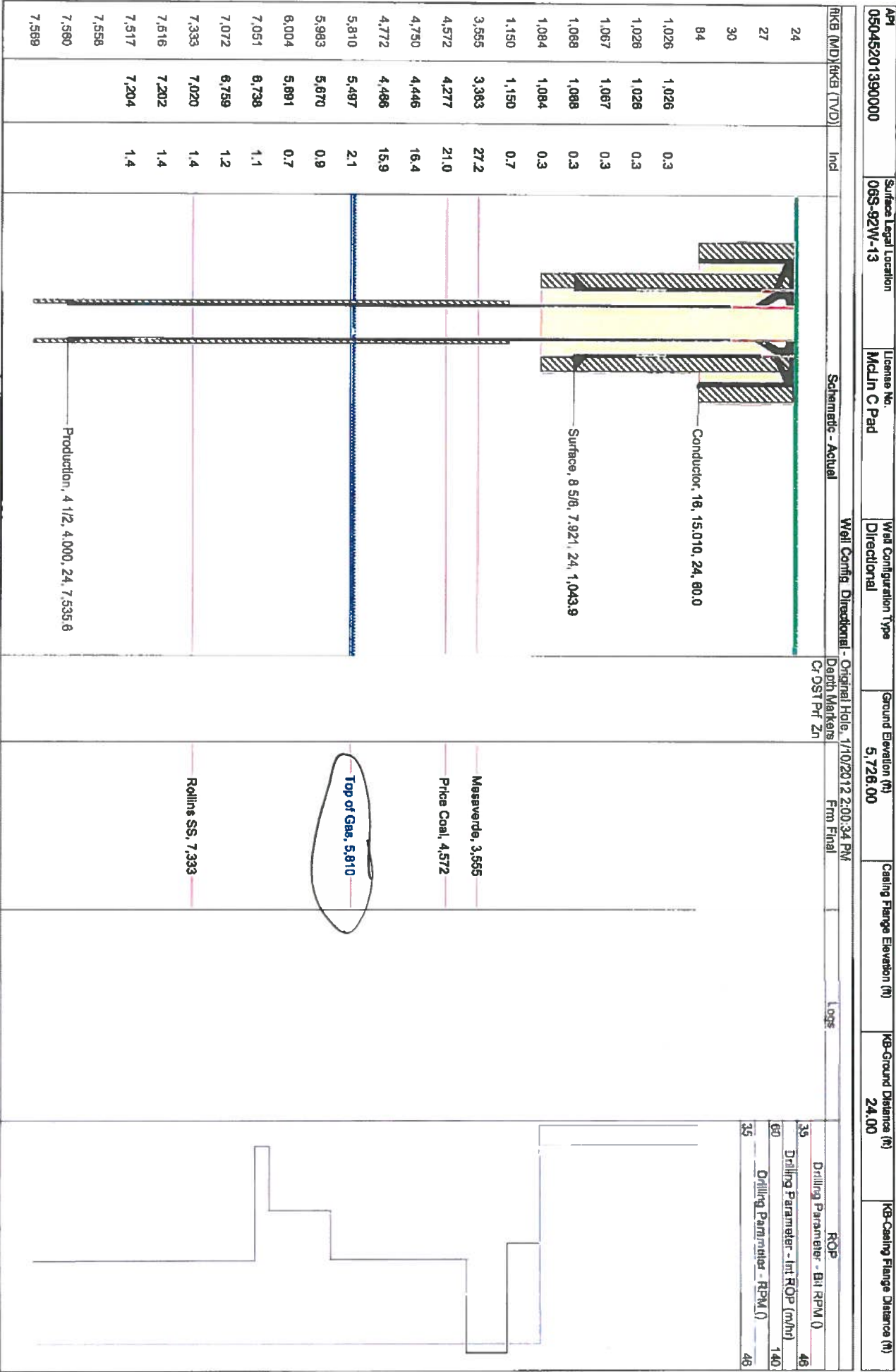
