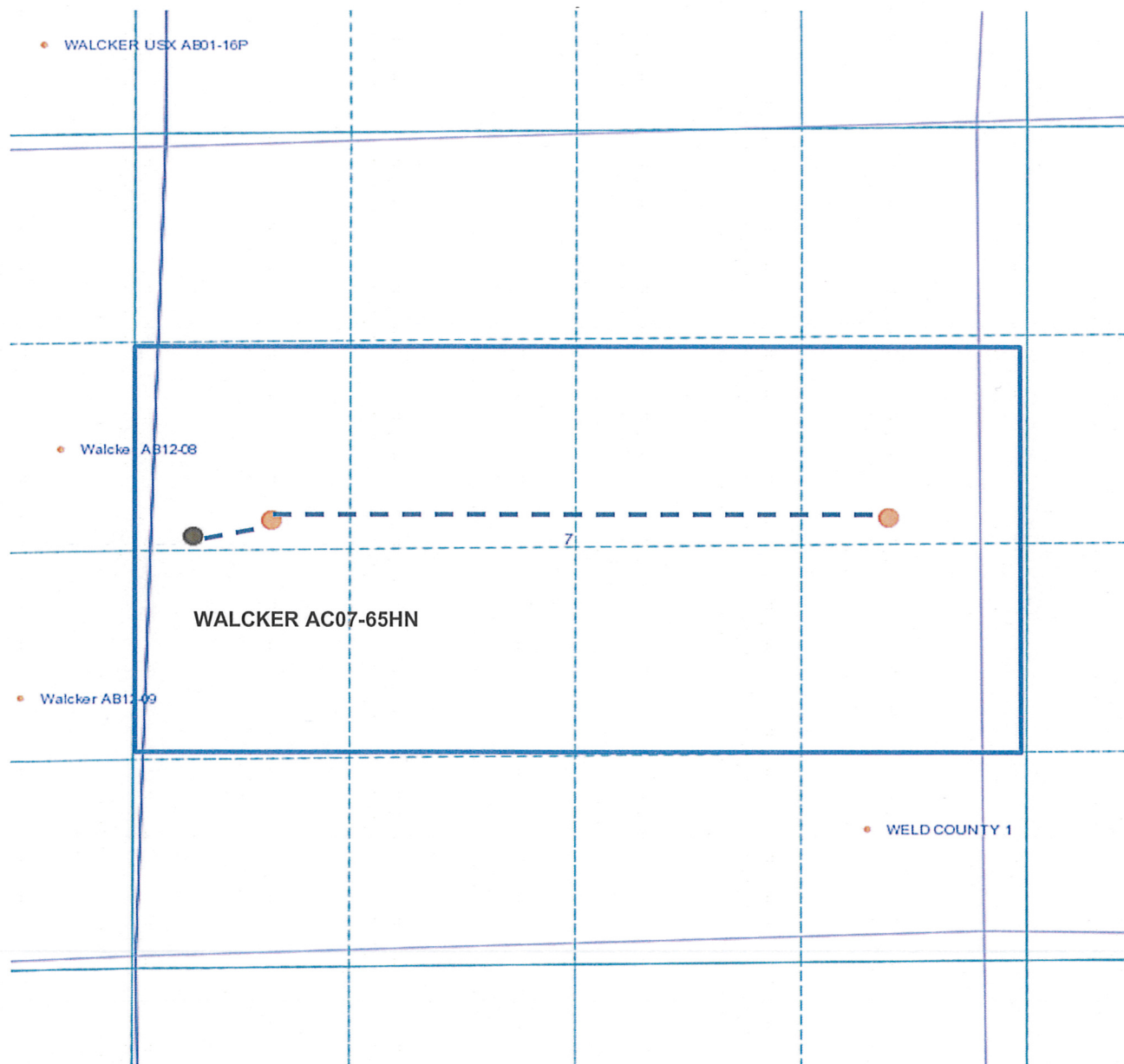

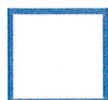

Bottom Hole Location

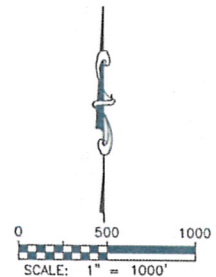
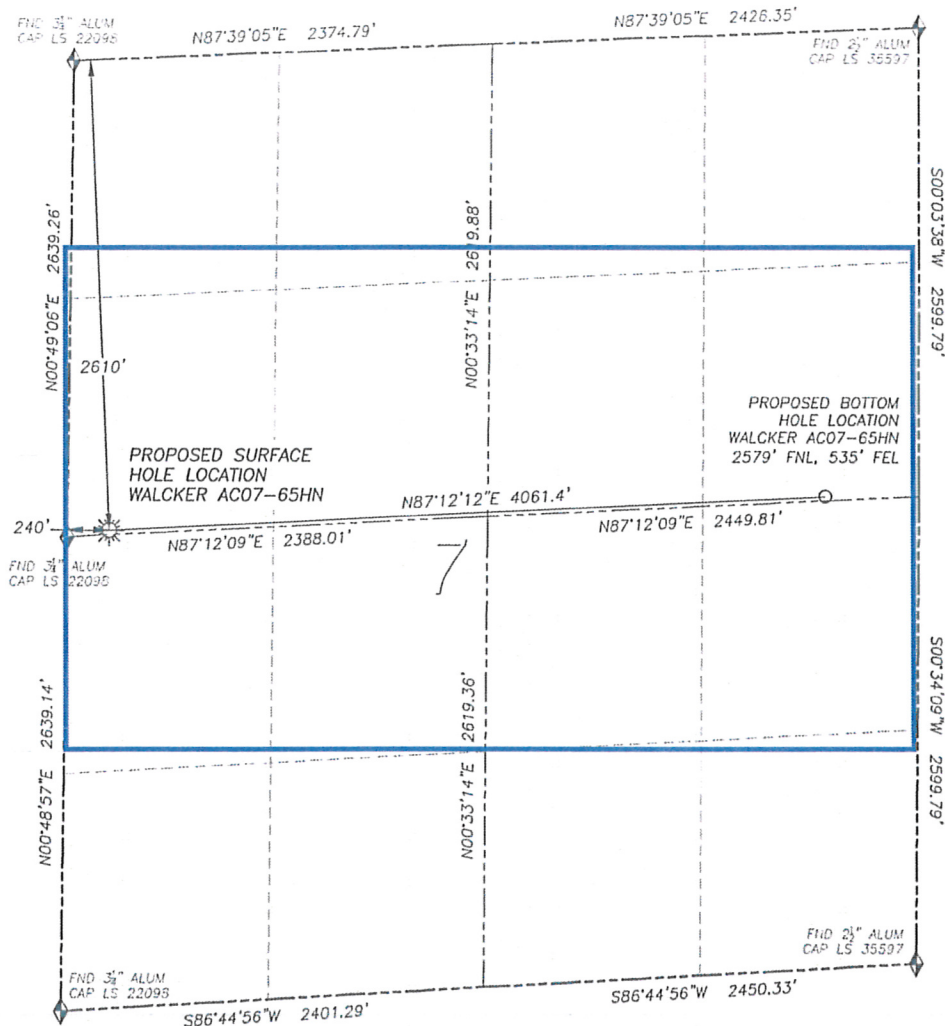

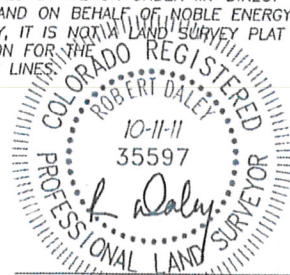
