RAILROAD IS 1.12 +/- MILES FROM SITE. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FT EXCEPT THE COUNTY ROAD - 328 FEET FROM SITE AND AN OVERHEAD UTILITY 300 FEET FROM SITE. NEAREST WATER WELL IS 3224 +/- FEET FROM SITE (RECEIPT - 0111541B, PERMIT - 28165, USE IRRIGATION). THERE IS A DRY INTERMITTENT STREAM 608 FEET FROM THE SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS SITE. IN MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE TO AID WITH GAS PRODUCTION. THE PUMPING UNIT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR.
