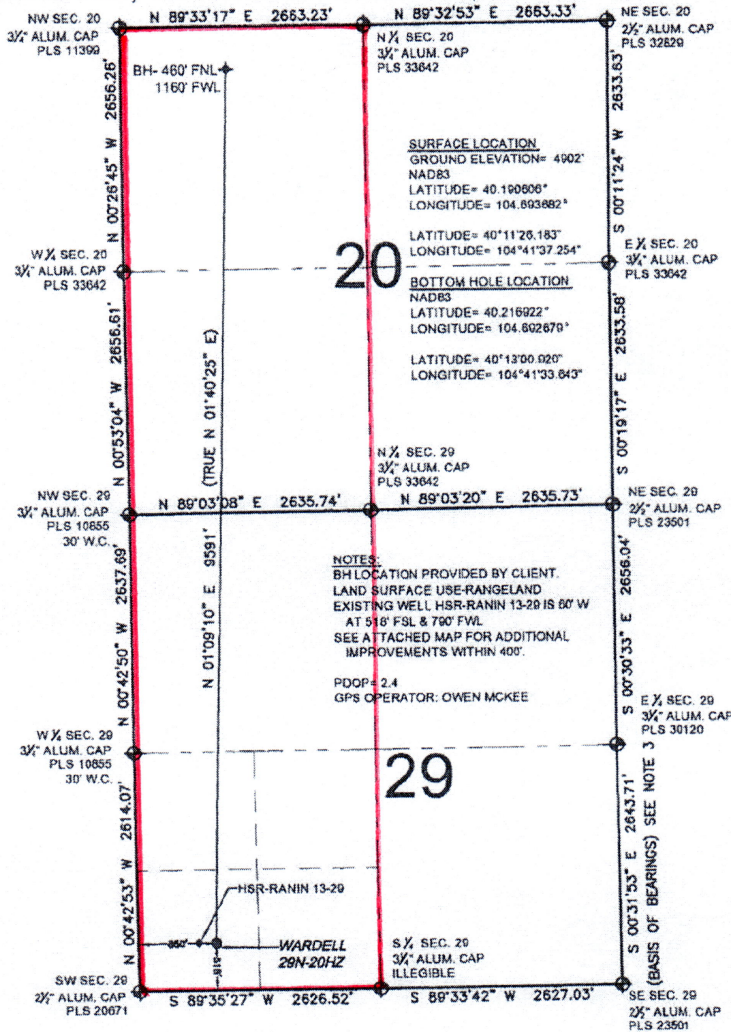

WELL LOCATION CERTIFICATE: WARDELL 29N-20HZ

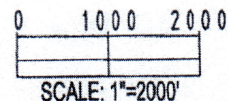
