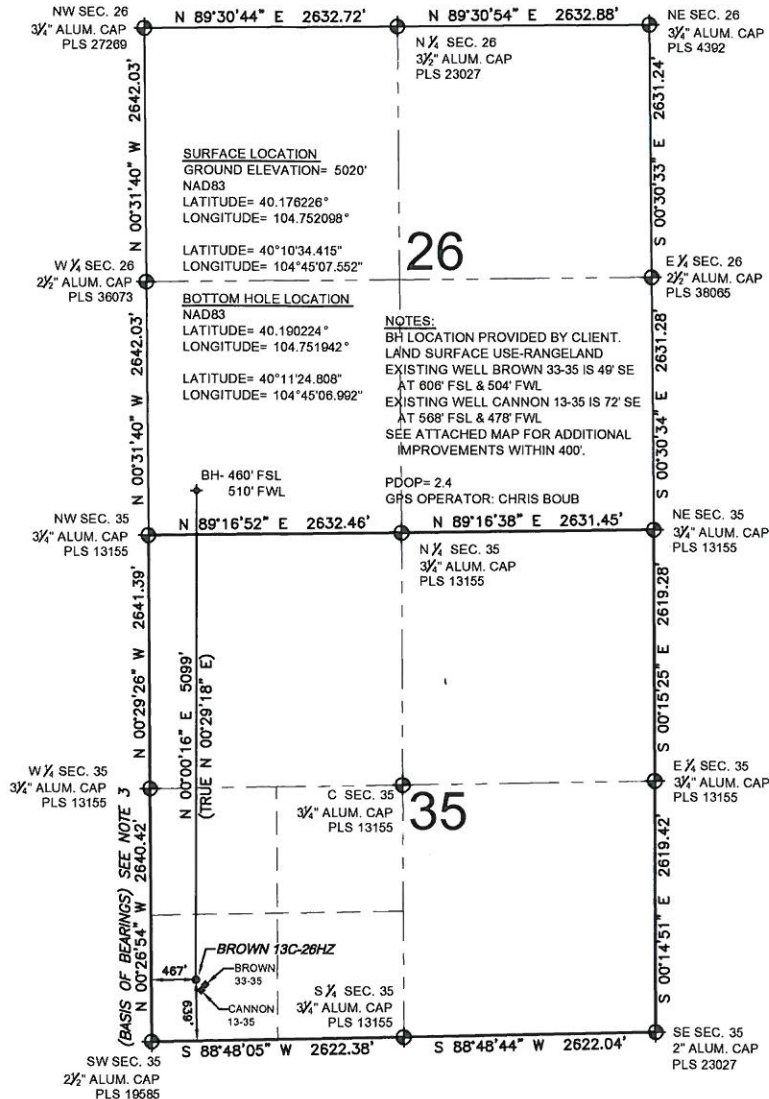


WELL LOCATION CERTIFICATE: BROWN 13C-26HZ

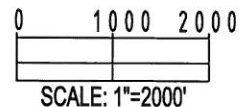

● = PROPOSED WELL ◆ = EXISTING WELL

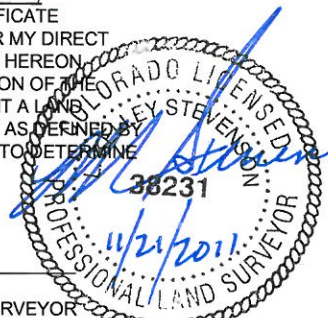
