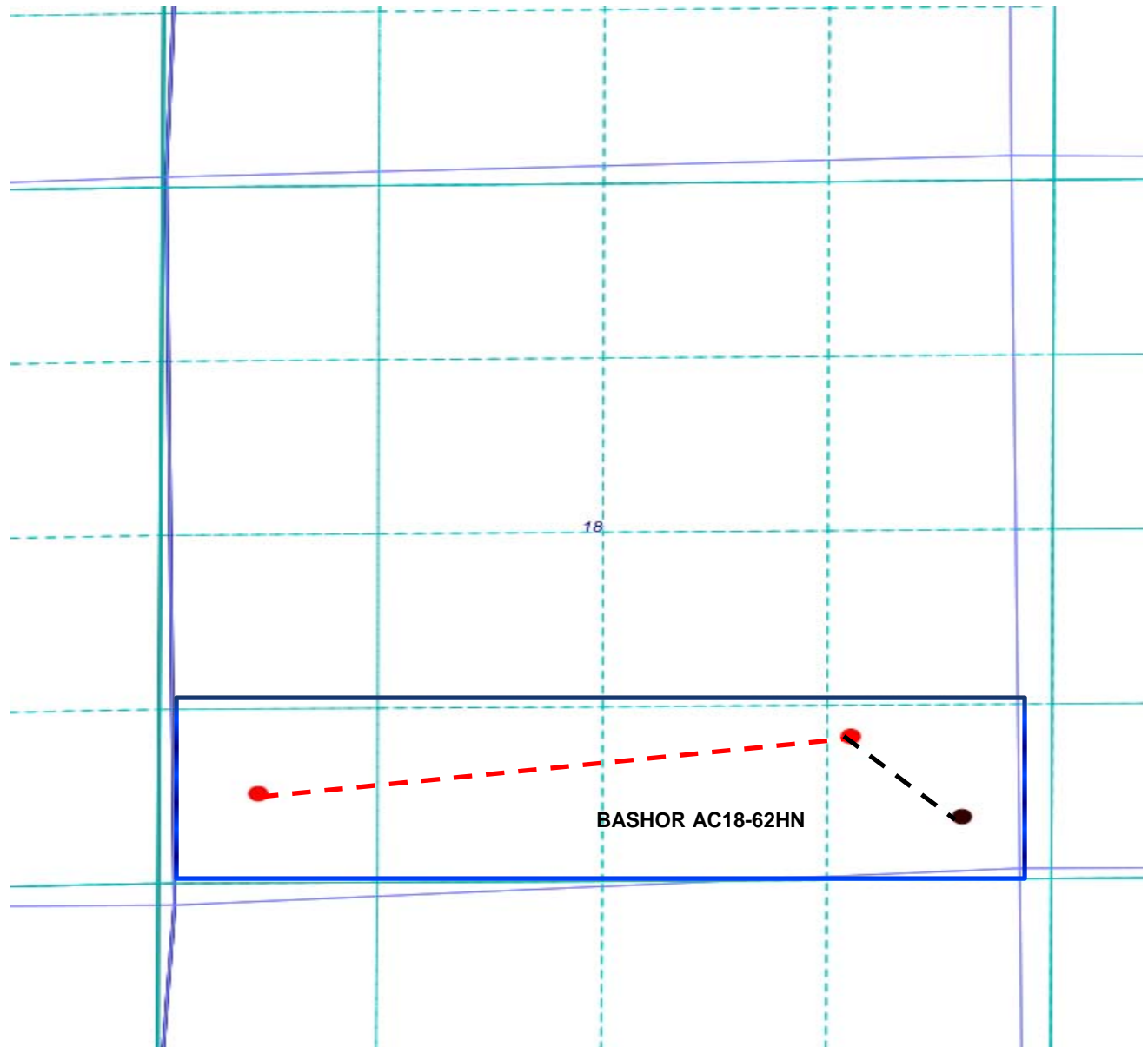

Bottom Hole Location

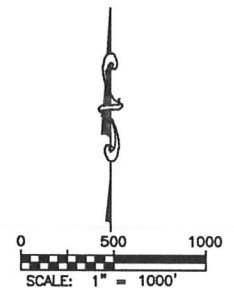
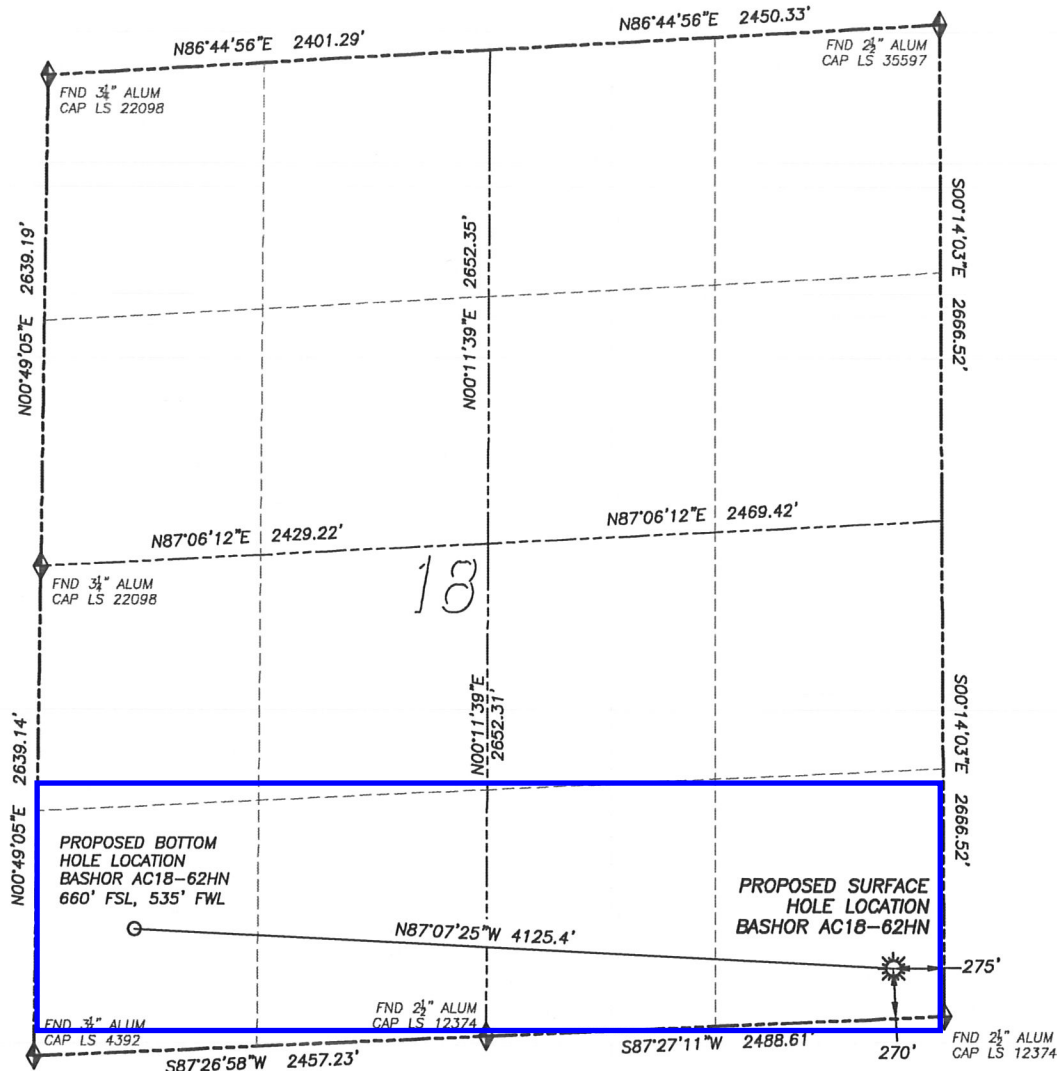
