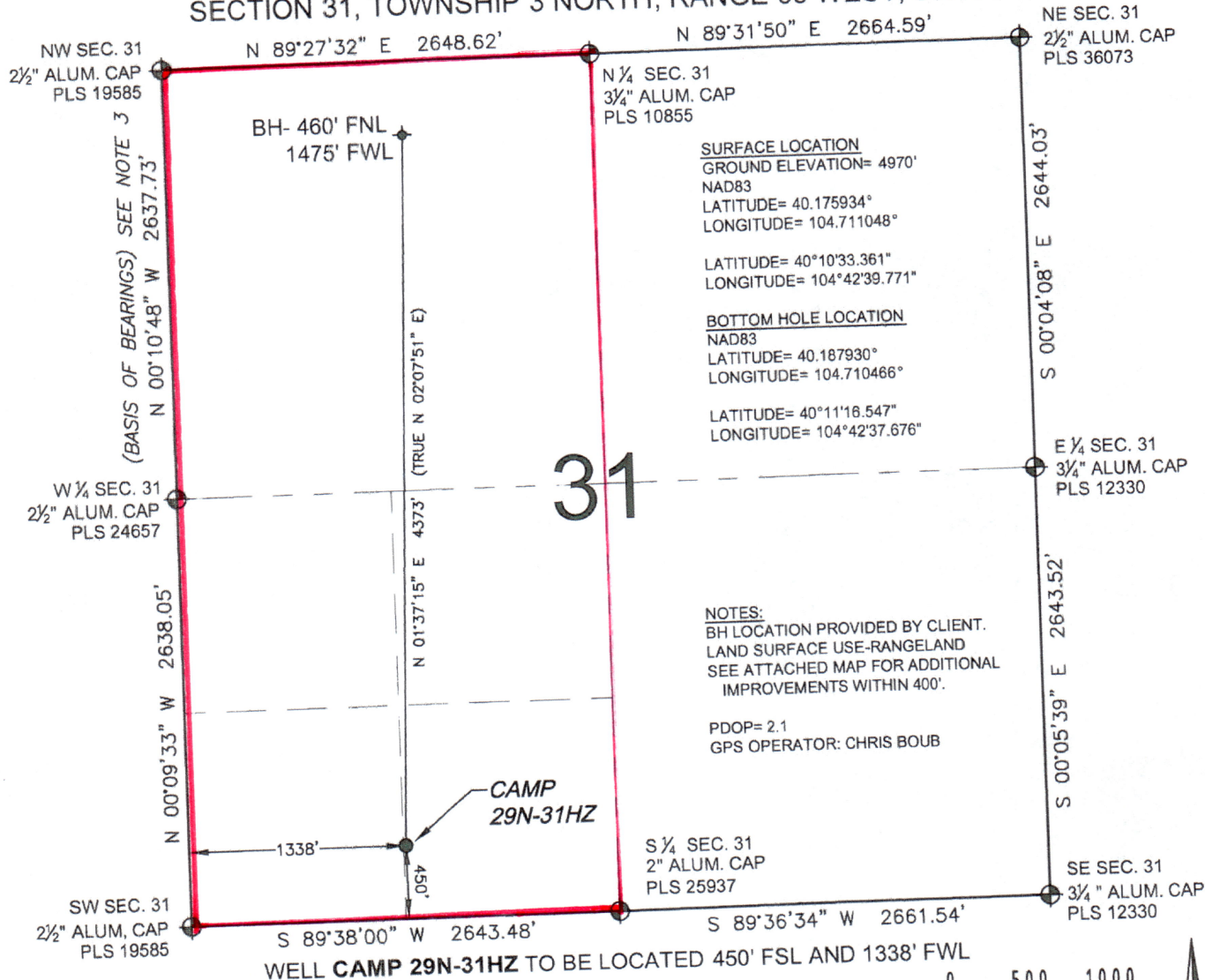

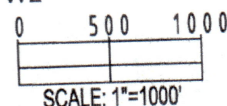
WELL LOCATION CERTIFICATE: CAMP 29N-31HZ

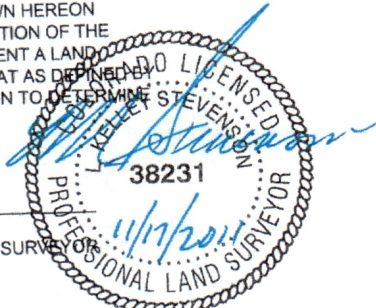
