Mr Sutphin,

Per our geologist we squeezed and tested an additional uphole zone prior to abandonment leaving the current wellbore condition as follows:

4857-4861 perms (Lansing test, unsuccessful)  
4840 CIBP w 2 sx cement  
4700-4701 squeeze perms  
4666 cement retainer, pumped 75sx below retainer  
CBL TOC @ 4310' (4700'-4310' behind csg)  
4618-4624 perms (Shawnee test unsuccessful)

Plan Forward:

Set CIBP @ 4600' w 2 sx cement

Proceed w below COGCC PA order:

Contact Craig Quint

1. perms @ 2500', cmt retainer @ 2400', 40sx
2. 20 sx in csg 1700-1850
3. 20 sx in csg 450-550
4. 10 sx 50-4'
5. Top annulus if open

please advise if acceptable, we plan on plugging tomorrow (Thursday 1/12/2012)

Jake, Zane,

Thanks for contacting me regarding plugging orders for this well and sending me the CBL. Here are plugging orders as we discussed.

- Plug #1: Perforate and pump 40 sx cement at 4700' with a retainer 100' above perms.
- Plug #2: Perforate and pump 40 sx cement at 2500' with a retainer 100' above perms.
- Plug #3: Set 20 sx cement in casing at 1850' – 1700'.
- Plug #4: Set 20 sx cement in casing at 550' – 450'.
- Plug #5: Set 10 sx cement in casing at 50' – 4'. Top up annulus if open.

Turn in a subsequent report when done. Include job tickets for all plugs and a wellbore diagram.
