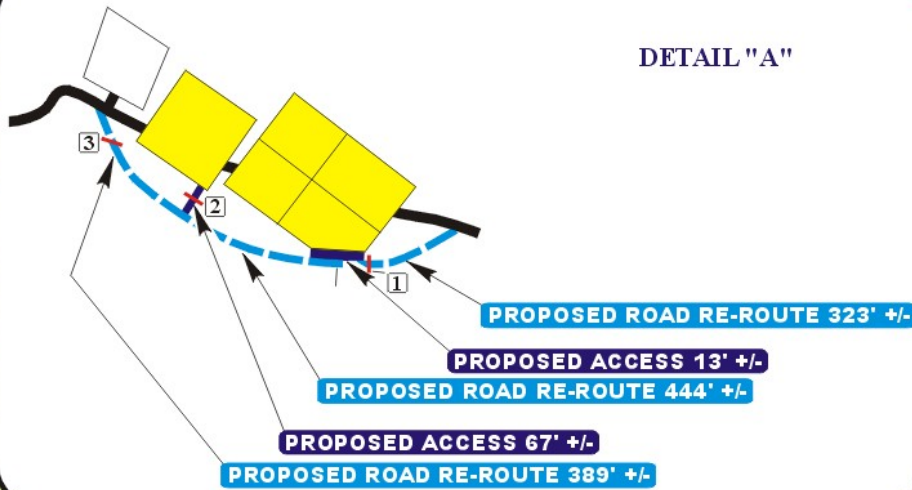

PROCEED IN A NORTHWESTERLY DIRECTION FROM GRAND JUNCTION COLORADO ON HIGHWAY 6 APPROXIMATELY 11.7 MILES TO THE JUNCTION OF THIS ROAD AND 16 ROAD TO THE NORTH; TURN RIGHT AND PROCEED IN A NORTHERLY, THEN NORTHWESTERLY, THEN NORTHEASTERLY DIRECTION CONTINUING INTO GARFIELD COUNTY ON HIGHWAY 205 APPROXIMATELY 20.9 MILES; CONTINUE IN A NORTHEASTERLY DIRECTION AT THE INTERSECTION APPROXIMATELY 0.1 MILES TO THE JUNCTION OF THIS ROAD AND AN EXISTING ROAD TO THE NORTHEAST; TURN RIGHT AND PROCEED IN A NORTHEASTERLY, THEN SOUTHEASTERLY DIRECTION APPROXIMATELY 2.0 MILES TO THE BEGINNING OF THE PROPOSED ROAD RE-ROUTE TO THE SOUTHEAST; FOLLOW ROAD FLAGS IN A SOUTHEASTERLY DIRECTION APPROXIMATELY 833' TO THE BEGINNING OF THE PROPOSED ACCESS ROAD TO THE NORTH; FOLLOW ROAD FLAGS IN A NORTHERLY DIRECTION APPROXIMATELY 13' TO THE PROPOSED LOCATION.

TOTAL DISTANCE FROM GRAND JUNCTION, COLORADO TO THE PROPOSED WELL LOCATION IS APPROXIMATELY 34.9 MILES.
