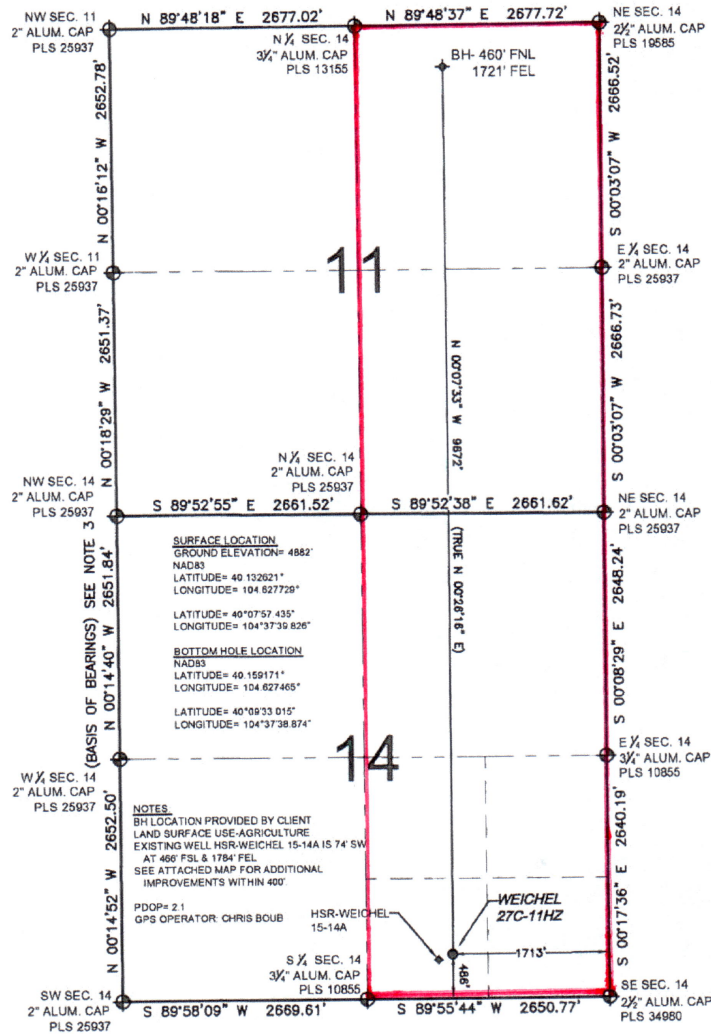

WELL LOCATION CERTIFICATE: WEICHEL 27C-11HZ

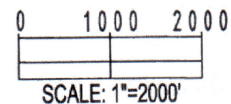

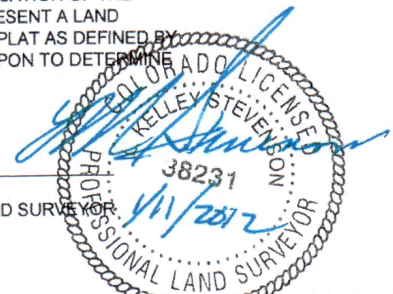
