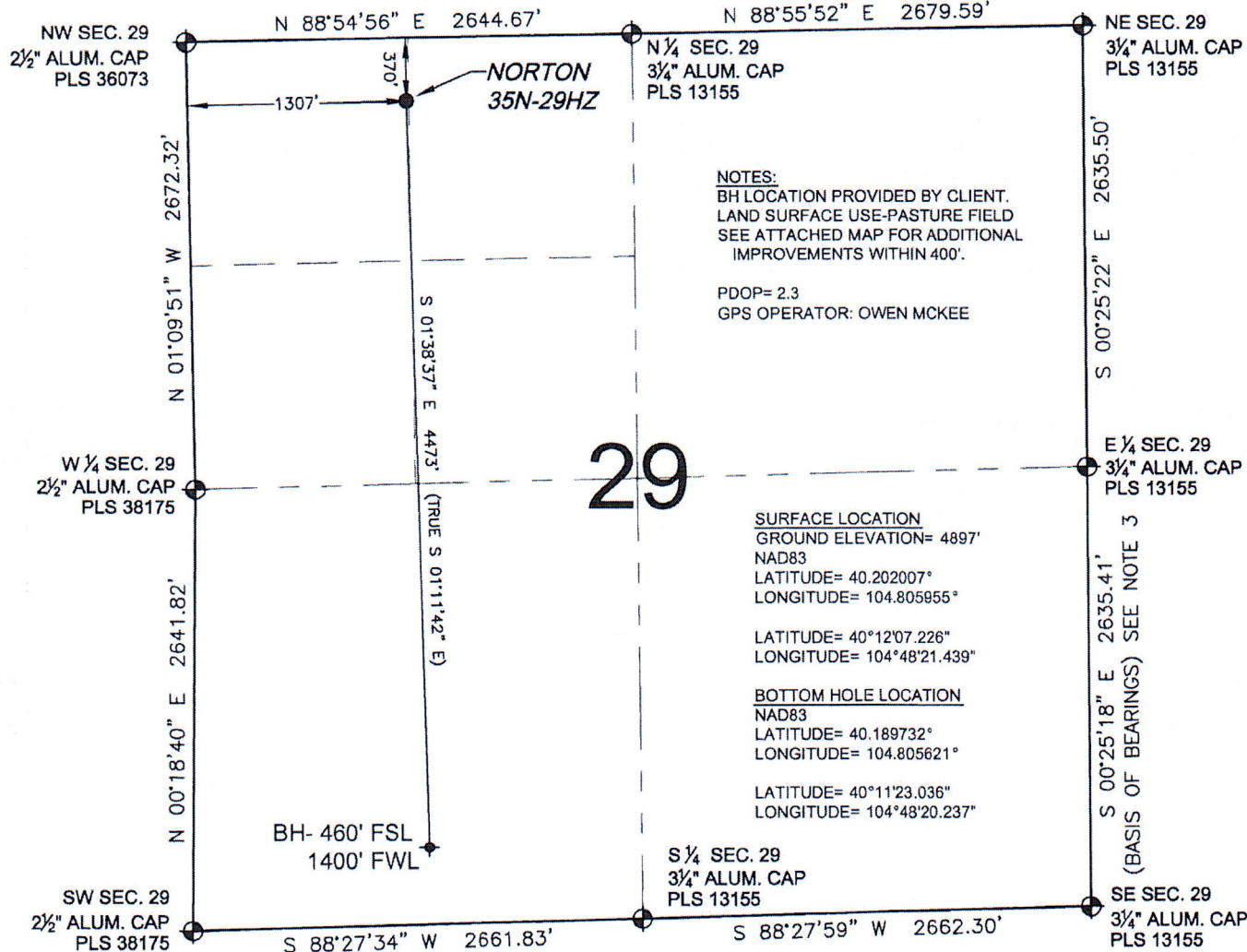

WELL LOCATION CERTIFICATE: NORTON 35N-29HZ

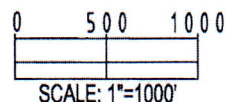

● = PROPOSED WELL ◆ = EXISTING WELL

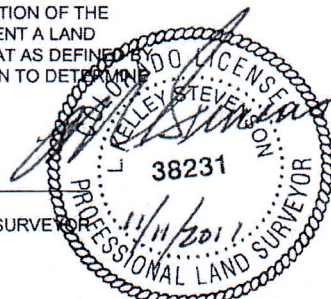
