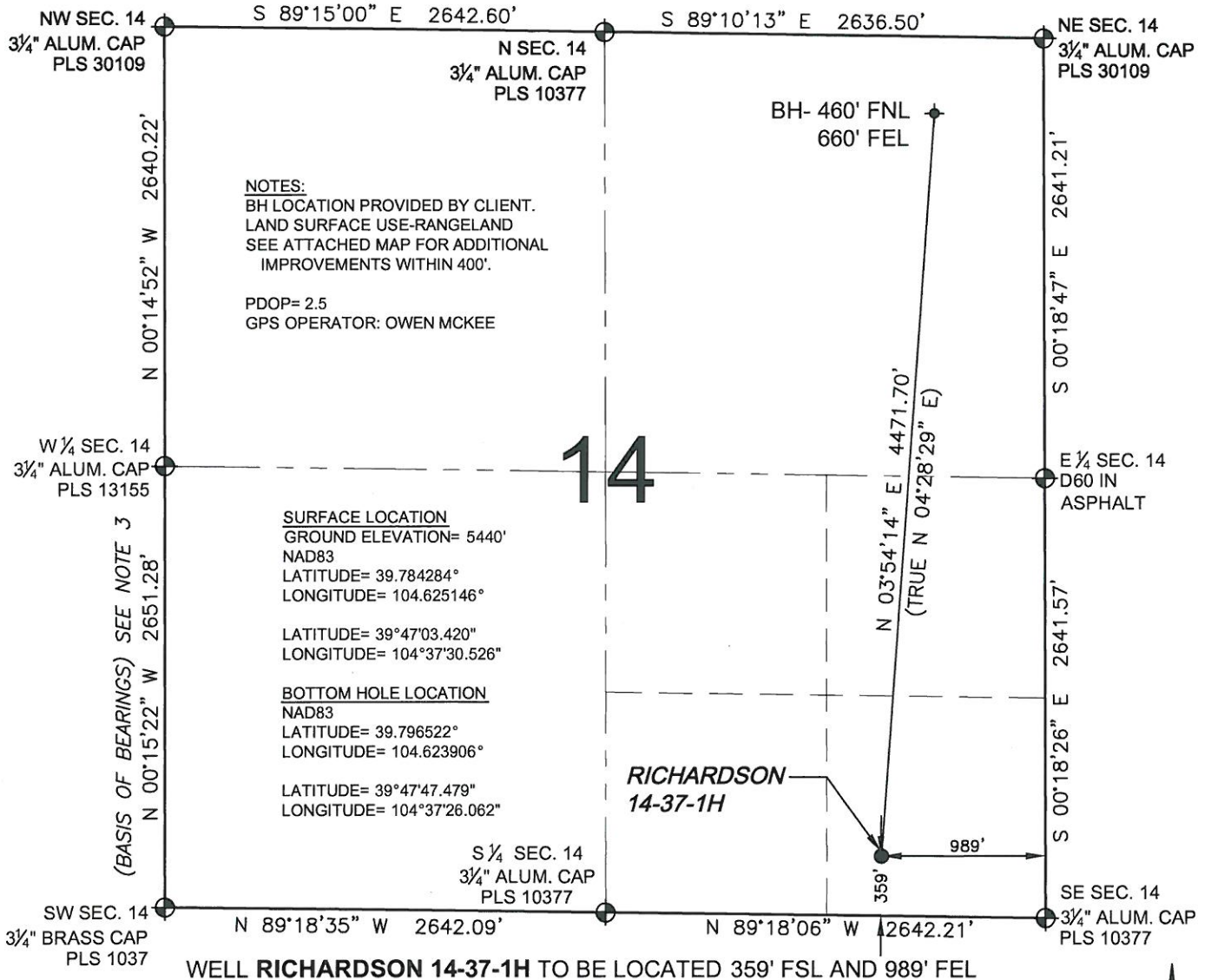


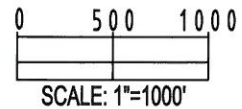
WELL LOCATION CERTIFICATE: RICHARDSON 14-37-1H

● = PROPOSED WELL ◆ = EXISTING WELL

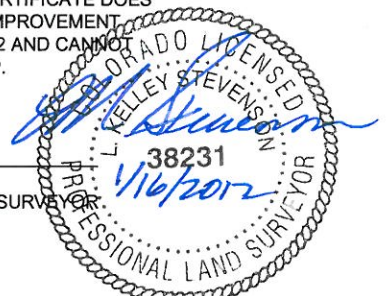
