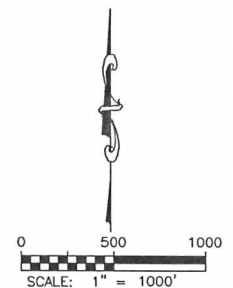
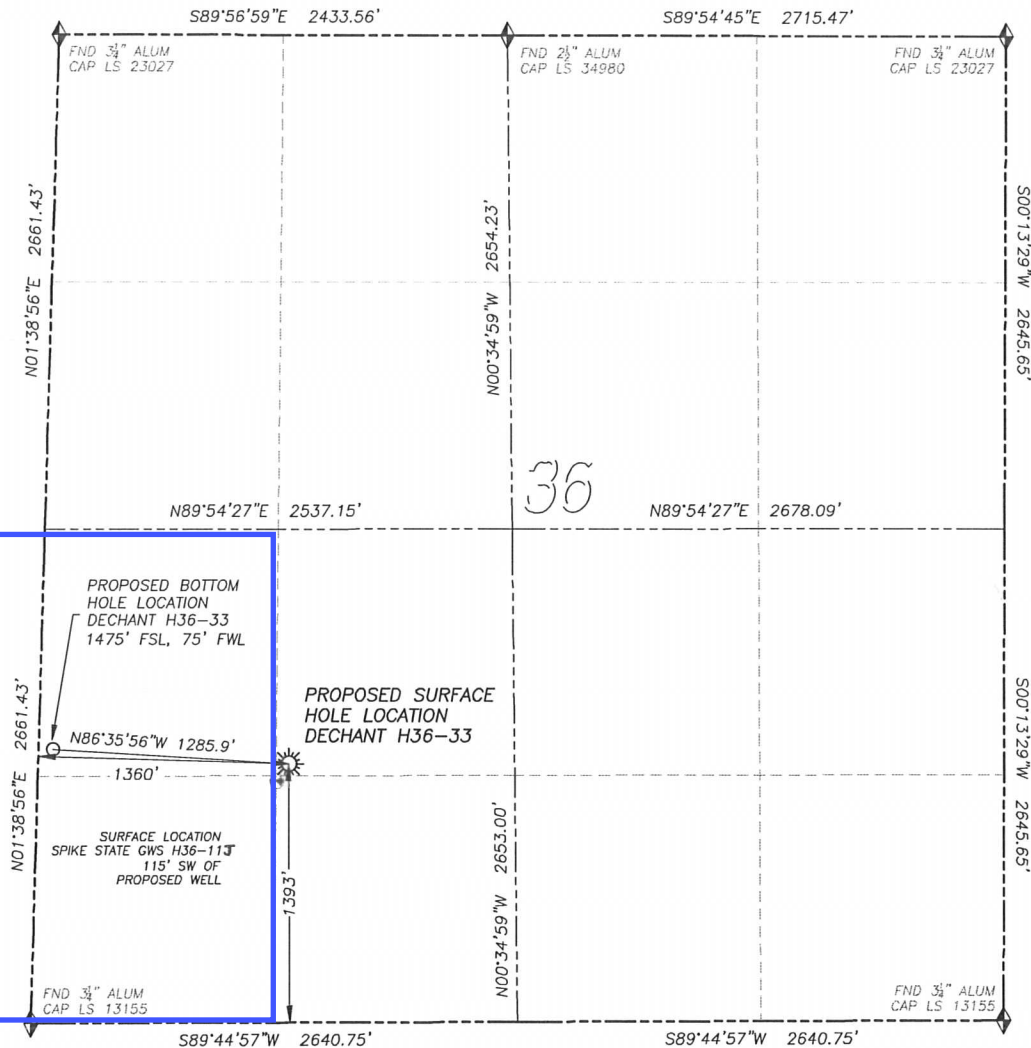


WELL LOCATION CERTIFICATE DECHANT H36-33
