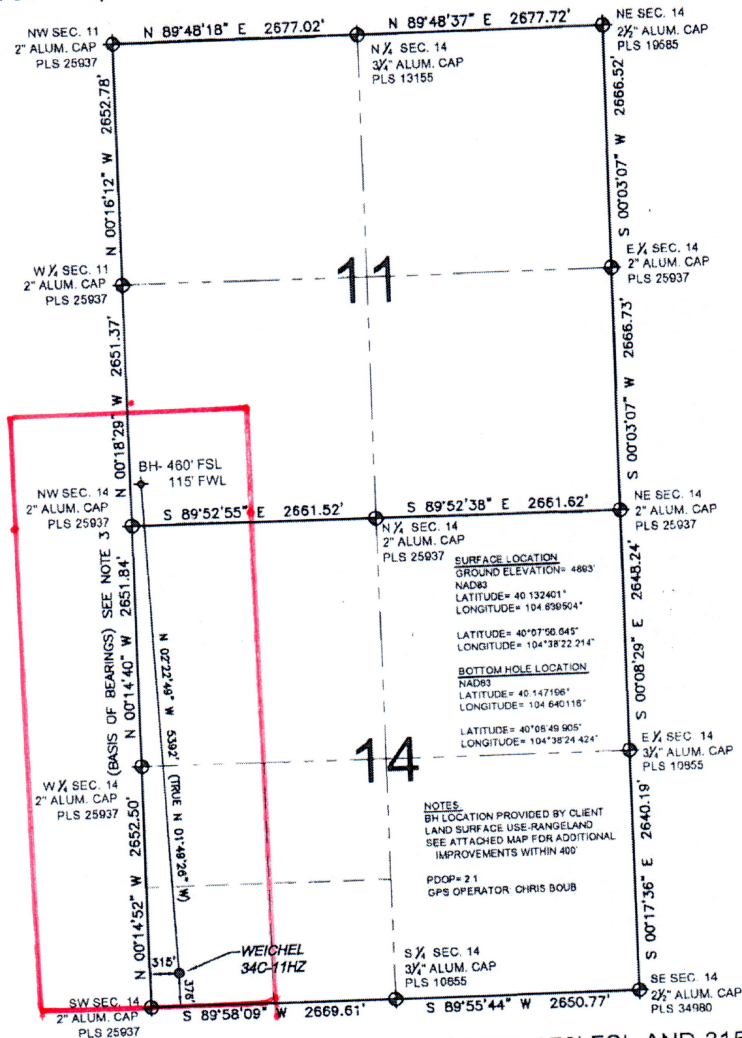

WELL LOCATION CERTIFICATE: WEICHEL 34C-11HZ

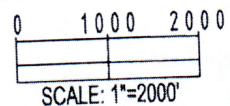
